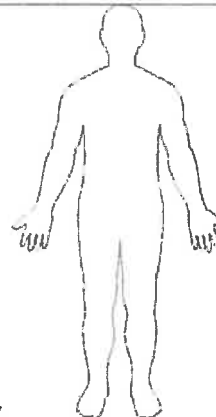

On December 31, 2018, at approximately 2237, I (Ofc Valdes Marrero) responded to 0 Duval (Ocean Key Resort), in reference to a battery. Dispatch advised there was a male subject that was beaten up by a couple of kids. It was later determined the male subject was the primary aggressor. The male was acting erratic, pushing and punching people and refusing to leave the location after being asked to do so by security. Video of his actions were later collected and placed into evidence.

Upon arrival, Ofc Dantu and I walked to the "Sunset Pier" which is located on the rear of Ocean Key Resort. On the pier, there was a New Year's celebration event with multiple guests. I observed a male (later identified per his New Jersey DL as Robert Teufel), arguing with a security officer. The security officer was trying to escort him off the property. Teufel also matched the description of a subject responsible for picking fights, arguments and being disorderly throughout Duval Street earlier in the evening. When Teufel saw Ofc Dantu and I, he redirected his attention to us and tried to quickly approach us. Teufel had a bloody face and continued to yell at us. Due to Teufel's aggressive demeanor, I grabbed his forearms in an attempt to escort him outside of the party zone, where it was quieter and where we could seek medical attention for his injuries. Teufel immediately tensed up, pulled away from me and was not following my verbal commands. I tried regaining control of Teufel by preforming a straight arm take down but was ineffective. I still had a hold of Teufel's right arm and was trying to flip him over onto his back, but Teufel was strong and was rolling onto his stomach instead. Teufel continued to refuse to place his hands behind his back as I was trying to detain him pending the battery investigation. Teufel was still tensed up and was not placing his hands behind his back. I used my Taser device and delivered a drive stun on Teufel's lower torso area to gain compliance. While drive stunning Teufel, he grabbed my right hand, my hand which the taser device was located, and tried to take it from me. Teufel tried taking my taser several times but was unsuccessful. Ofc Dantu, Ofc Arguello, a random bystander and I were able to subdue Teufel and I handcuffed him. Teufel remained on the ground until EMT's was able to bring a stretcher to our location.

I notified the sergeants on duty over channel 1 of the use of force incident. Ofc Dantu remained on scene and collected 3 written witness statements. The statements summarized that Teufel was highly intoxicated and was acting disorderly in the premises. Teufel was attempting to start fights, grabbing people's belongings, pushing and smacking individuals. Teufel was confronted by 2 other unknown subjects and Teufel was punched on the face. Teufel sustained his face injuries from this altercation. These individuals left prior to my arrival and I could not get their statements on the case. Teufel was also asked to leave the property several times by security but refused to so.

Teufel was transported to Lower Keys Medical Center (LKMC) for further evaluation due to the face injuries he sustained prior to our arrival. While en-route to LKMC, Teufel continued to yell profanities at EMT staff. EMT's said Teufel was possibly under the influence of some type of narcotic due to his erratic behavior. Teufel tried spitting blood at several of the EMT's so they placed a mask over his mouth to prevent him from doing so. Teufel remained combative for most of the transport to LKMC even after being sedated.

I remained at LKMC monitoring Teufel's medical status. LKMC personnel advised Teufel was going to remain under their care for several hours due to him being sedated.

Due to exigent circumstances, Teufel was not able to be transported to the jail. I will prepare a warrant for his arrest on my next duty day. My BWC camera, pictures of the injuries, video of Teufel behavior prior to our arrival and written statements were all submitted for evidence.

On 12/31/2018, about 10:47pm, I (Ofc. Dantu) was dispatched to 0 Duval Street, (Ocean Key Resort) in reference to a battery.

Upon arrival, Ofc. Valdez and I were told by security that there was a male person who was bleeding at the bar. Ofc. Valdez and I made contact with Robert Teufel who was non compliant. Teufel attempted to approach us in a quick and sudden movement. Teufel's face was full of blood and Ofc. Valdez attempted to stop him from getting to close by grabbing his hands.

Teufel resisted. I grabbed Teufel's left hand and Ofc. Valdez grabbed Teufel's right hand and we attempted to escort him away from the bar area.

Teufel resisted and Valdez took him to the ground. Once on the ground Teufel resisted both me and Ofc. Valdez as we attempted to handcuff him. Teufel refused to obey lawful commands.

Ofc. Valdez told Teufel to stop resisting otherwise he would be tased. Teufel continued to resist. Ofc. Valdez drive stunned Teufel. Teufel did not stop resisting.

Ofc. Arguello arrived on scene and helped detain and handcuff Teufel.

Teufel continued to resist until he became exhausted. Rescue arrived on scene. Teufel was transported to Lower Keys Medical Center.
