- The CRB and its employees and agents are not your legal representatives. You should seek independent legal representations to understand your legal rights regarding the matters referenced in your complaint.
- The CRB jurisdiction is limited to City of Key West Police Officers and NOT Monroe county sheriffs, correction officers, Florida Fish and Wildlife Officers, FDLE representatives, Florida Highway Patrol Officers, Federal Agents, Military personal and alike.



My original complaint was made with the help of Lt. Ream who consulted with Captain Torres, who seemed to agree with the Lt. and I, and seemed concerned with what he heard. He took my complaint from Lt. Ream and promised to bring the issue to a conclusion, but I would have to wait a week or so to give him time to review the evidence I provided. That was over 3 months ago.

In that time the IA Sarg. Castillo was asked to address a very basic complaint I had against Donnie Lee, Castillo investigated the issue and questioned Donnie Lee, and then concluded his report and provided a copy to me. This complaint required the answer to one question (see attached complaint). And Torres felt that since one question was answered by the IA, that if I asked anything else it would be "asking to much" and "its never enough for me" and "nothing is enough for you". Our "conversation" ended with Torres yelling these quotes repeatedly into the phone very loudly in an angry violent manner of an unstable person that possibly had just lost a promotion. He also said that he agrees with the conclusion of the IA report, he seems very hung up on the simple complaint the IA handled for me and didn't want to talk about much else, repeated attempts to bring the "conversation" back to the complaint Lt. Ream helped me bring to Torres were unsuccessful. His meltdown escalated until I had to terminate the call. I would like to thank IA Castillo for taking my complaint and conducting a timely investigation and conclusion, a conclusion I disagree with.

The complaint I filed with Lt. Ream/Torres has some small overlap with the complaint I filed with IA Castillo. This overlap concerns Donnie Lee's conduct. This conduct was addressed in the IA report so I asked Torres to ignore any overlap concerning issues with Lee and instead focus on the rest of the complaint concerning the conduct of Jeff Dean, Betz, Andruzzi, Blasenbergs. He yelled into the phone that since the IA addressed the basic complaint I brought to the IA (Attached)...that he no longer had to address the complaint I brought him concerning issues with these other officers.

Torres also told me the report was being created as we spoke, and that Ream was "helping him type it up, cause she is good with typing" ..jeeesh, sounds a bit sexist, and sounds like a lie. Ream should be asked if she was involved with typing up a report for the complaint she is involved with.

The KWPD process for a complaint reads ... "The investigators completed report will be reviewed and a conclusion of fact will be made based on preponderance of the evidence" Torres is in gross violation of this process and is acting in an extremely unprofessional and frightening manner.

- I would like to see my complaint filed with Ream/Torres investigated and brought to an conclusion
- I would like the issues concerning Jeff Dean, Betz, Andruzzi, Ane and Blasenbergs addressed and resolved
- I would also like Torres to be held accountable to his obstruction in this manner.
- I would like to see Torres go through some type of exam to see if he is fit and safe to be out among the community, the volume and anger he expressed though his yelling was quite alarming for someone who carries a firearm.
- I would also like Torres to go through any retraining needed to educate him of current law that he is currently confused about.
- I would also like LT. Ream to be consulted on this complaint as she was present for some of these conversations.

This is brief description of the events that took place on July 12, 2018. I (Lt. Kathleen Ream) watched Officer Betz's video (BWC) about the incident and spoke to Mr. Legnaioli his concerns with how Officer Betz, Officer Andruzzi, Officer Ane, and Sgt. Blasberg handled this encounter.

Mr. Legnaioli called the Key West Police Department (KWPD) to report an IRS scam. Mr. Legnaioli called the phone number back and spoke to the person that he believed threatened him and used the word "kill" toward him over the phone. Mr. Legnaioli believes this person is located in New York and the KWPD should have taken his report seriously and investigated it so if the suspect trying to defraud citizens was located in this county that that person could be apprehended. Mr. Legnaioli wants the government to stop "them"- the scammers. Officer Betz tried to explain to Mr. Legnaioli that more than likely the person was not in the United States.

Mr. Legnaioli asked Officer Betz if the scammer is calling from within the United States would KWPD arrest him. Officer Betz told Mr. Legnaioli it would be another jurisdiction's case. Mr. Legnaioli became very upset about this statement and informed Officer Betz that jurisdiction resides with where the victim resides. Mr. Legnaioli became more upset because he feels this was an issue in a previous case he was involved in and KWD has failed to train officers to know that the jurisdiction resides with the victim's location. Mr. Legnaioli referred to alleged pending litigation were this was a topic of contention.

Mr. Legnaioli was also upset because Officer Ane told him that when a threat is made over the phone, there is no ability to carry out the threat so it is not a crime, this upset Mr. Legnaioli more. Mr. Legnaioli told Officer Ane and the KWPD had previously arrested him (Mr. Legnaioli) twice for making two threatening phone calls on two separate occasions and it was "thrown out".

The situation/conversation between Mr. Legnaioli and the officers (Officer Betz and Officer Ane and Officer Andruzzi who had arrived early on) became non-productive and the officers were told by Mr. Legnaioli to leave and the officers ultimately did.

Mr. Legnaioli says that he later talked to Sgt. Blasberg who did not know jurisdiction resided with the victim's location.

I met with Mr. Legnaioli who wants to file a complaint for deficient service and he believes the officers and supervisor may have committed a crime in the process, under "Color of Law".

Mr. Legnaioli would like this matter investigated for Department violations and Criminal Charges.

I has spoken to Mr. Legnaioli several times in the past few weeks. On August 7 I called him reviewed his compliant and read him this brief overview and provided him direction on picking up the "Explanation of the Complaint and Commendation Process" and the "Citizen Complaint Sworn Affidavit". I informed him he could add any additional information that he felt was pertinent. I told him once he was satisfied with it Records could notarize the form or he could take the form/documents and return them at his convenience notarized.

When I spoke to Mr. Legnaioli on August 7, 2018 he seemed satisfied with the overview I have prepared on his complaint.

The reason the complaint has been filed with the lieutenant is because internal affairs will not return my calls , and Randy Smith of IA has threatened me in the past by saying "if you file a complaint against me you are not gonna like what happens to you "

I turned to his superior Captain Brandenburg , who agreed with Smith , that a threatening call coming from outside KW into KW does not fall under their jurisdiction. He also refused to take my complaint.

I feel the police have shown a pattern of trying to bait me in a malicious way by repeatedly stating this unlawful position ...so that I could be baited into being arrested , as shown in the body cam footage of the 3 officers in this complaint.

I have spoken to State Attorney Dennis Ward about this issue , he made a call to the KWPD and instructed them that their "interpretation" of the jurisdictional laws was not accurate and it should stop. He also assured me that IA would now take my complaint , I then called KWPD IA and spoke with Randy Smith who said he disagreed with the SA's interpretation of the law and still wouldn't take my complaint , I told Smith I would file a complaint on him and he then threatened me.

The SA's instructions were ignored and the KWPD continue to tell me I can threaten people on the phone , and that jurisdictional falls where the call is made instead of where the victim is.

The Chief of Police Donnie Lee is also aware of this complaint and the jurisdictional issue it created , he made it very clear that he believes that a threatening call coming from outside KW jurisdiction doesn't fall under their jurisdiction,
