- What you need to know before completing the attached complaint form:
- This complaint and any attachment become public record. If you have already filed a report with the Key West Police Department Internal Affairs, and you want that complaint to remain confidential until the investigation is complete, you may want to refrain from filing a complaint with the CRB at this time.
- Complaints should be filed as soon as possible of the time you became aware of the incident or after resolution of any criminal charges.
- Anyone who has criminal charges pending related to this complaint should consult an attorney before filing the complaint with the CRB and such pending charges may delay the progress of the investigation of your complaint with the CRB. Further, any statements made to the CRB are public record and can be used by anyone to incriminate the complainant. All statements will be uploaded to the internet.
- Complainants must advise the CRB of any changes of address or phone number; failure to provide the CRB current information or means for CRB to contact the complainant may result in dismissal of the case.
- All documents received by this office, including medical records, photo IDs, communications and alike become public records and will be disclosed on the Internet and viewable by anyone or any person. You should consider this fact before sending any matters or materials to this office.
- All CRB meetings are televised and archived on the City of Key West web-site. By attending a CRB meeting you may be shown on camera.
- The CRB and its employees and agents are not your legal representatives. You should seek independent legal representations to understand your legal rights regarding the matters referenced in your complaint.
- The CRB jurisdiction is limited to City of Key West Police Officers and NOT Monroe county sheriffs, correction officers, Florida Fish and Wildlife Officers, FDLE representatives, Florida Highway Patrol Officers, Federal Agents, Military personal and alike.



Brandenburg violated the law and my rights on Jan. 2nd 2019 when gave his opinion on complaints filed by Legnaioli and allowed those unlawful positions to be heard at a meeting with Castillo, Smith, and CRB head Tom Pakenas where Brandenburg claimed they were not in violation of 112.533 because the requirements outlined in the statute are optional for them. Brandenburg failed to intervene when he saw that Scholl, Smith and Castillo were violating my constitutional rights by taking such a position that 112.533 was optional.

Brandenberg also failed to intervene or conduct a investigation when he witnessed the Chief of police signature on a Internal Affairs report stating 365.16 requires the call come from within the jurisdiction of KWPd for it to fall under their jurisdiction and authority, Brandenburg , and Castillo claim the KWPd could not investigate my original police report that my family was being harassed and threatened by someone on the phone because the call came from outside the jurisdiction of the KWPd, that jurisdiction fell where the call was placed. Lee gave Castillo a signed statement on his position, and Brandenburg failed to act.

I feel Brandenburg has violated 112.533 and I am a victim of his actions, I also believe that there are 1983 rights violations a result of Brandenbergs behavior. I feel my family and myself have been target by Brandenburg and the KWPd and our safety is in question.

Castillo also allowed the procedure for receiving and investigating complaints to be hijacked by Brandenburg , Smith and Scholl by bypassing requirements under 112.533. Castillo violated the law and my rights on Jan. 2nd 2019 when gave his opinion on complaints filed by Legnaioli and allowed those unlawful positions to be heard at a meeting with Brandenburg, Smith, and CRB head Tom Pakenas where Castillo claimed they were not in violation of 112.533 because the requirements outlined in the statute are optional for them. Castillo failed to intervene when he saw that Scholl, Smith and Brandenburg were violating my constitutional rights by taking such a position that 112.533 was optional.

Castillo also failed to intervene or conduct a investigation when he witnessed the Chief of police signature on a Internal Affairs report stating 365.16 requires the call come from within the jurisdiction of KWPD for it to fall under their jurisdiction and authority, Brandenburg , and Castillo claim the KWPD could not investigate my original police report that my family was being harassed and threatened by someone on the phone because the call came from outside the jurisdiction of the KWPD, that jurisdiction fell where the call was placed. Smith violated the law and my rights on Jan. 2nd 2019 when gave his opinion on complaints filed by Legnaioli and allowed those unlawful positions to be heard at a meeting with Brandenburg Castillo, and CRB head Tom Pakenas where Smith claimed or stood by while others claimed they were not in violation of 112.533 because the requirements outlined in the statute are optional for them. Smith failed to intervene when he saw that Scholl, Castillo and Brandenburg were violating my constitutional rights by taking such a position that 112.533 was optional.

I feel Smith has violated 112.533 and I am a victim of his actions, I also believe that there are 1983 rights violations a result of Smiths behavior. I feel my family and myself have been target by Smith and the KWPD and our safety is in question.
