- The CRB jurisdiction is limited to City of Key West Police Officers and NOT Monroe county sheriffs, correction officers, Florida Fish and Wildlife Officers, FDLE representatives, Florida Highway Patrol Officers, Federal Agents, Military personal and alike.

On Jan. 17th 2019 around 10:30 pm I met with Sgt. Barrios who took a report on a crime committed where I was the victim.

The KWPD failed to investigate complaints filed with the Internal Affairs. There reason for doing so is Brandenberg, Castillo, Smith, and Scholl claimed Florida Statute 112.533 was optional. An hour after meeting with Barrious he called and told me he felt that 112,533 is optional, that it didn't have to be followed by the KWPD because it was common law, or administrative law. I then explained to him that it is a statutory law, it is a florida statute passed by legislative process. He disagreed Florida Statute 112.533 is a Statutory law. He then stated the Statute provides for no punishment if violated, I then explained to him that the statute does cover punishment, it is at the discretion of the KWPD AFTER an investigation has taken place by Internal Affairs. In this case 112.533 was ignored and the punishment was determined without investigation, in violation of 112.533. I also suggested former Chief Lee could be liable and could be arrested, Barrios then stated that if he was guilty of a crime, they couldn't arrest him anyway, claiming they had no authority over a KW Citizen that has violated a law...especially where there is a victim. I feel Sgt. Barrious failed to intervene when he discovered my rights were being violated. He violated 112.533 when he agreed that it is optional, he intentionally ignored Statutory law and called it optional. I feel Barrios has maliciously targeted me.
