#### Good afternoon Xiomara,

Metric forgot to negotiate the rates for one position. They negotiated the rates for all other staff with the City at the end of last year but forgot to include this one. They need to add a registered engineer with 10 years post design experience. Specifically, the work class needed is SENIOR ENGINEER.

The individual proposed has over 40 years of experience, most of it is in other areas and not in roadway. Nonetheless, the project is not that complex, and I was assured by the PM that he is more than capable to do the work.

As a side note, although his post-registration experience is over 40 years, the rate to be negotiated should be only equal to that of someone with just over 10 years post-experience since that is all that is needed. I believe they'll have to go back to the City to negotiate the rate for this, and amend it to the contract. I just wanted to make sure this is the correct process. Please advise.
