A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, ACCEPTING THE RANKING, APPROVING THE SELECTION COMMITTEE RECOMMENDATION AND AWARDING A CONTRACT TO AECOM IN RESPONSE TO RFQ 18-003 FOR CULTURAL RESOURCES ASSESSMENT UNDER FDOT AGREEMENT FM# 440023-1 FOR THE BAHAMA VILLAGE CONNECTIVITY PROJECT IN AN AMOUNT NOT TO EXCEED \$202,491.41 (TASK #1 FOR A CULTURAL RESOURCES ASSESSMENT IN THE AMOUNT \$50,002.00, TASK #2 FOR A CULTURAL RESOURCES SURVEY THE INAMOUNT \$152,489.41, CONTINGENT UPON THE COMPLETION OF TASK #1); AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS; AUTHORIZING ANY NECESSARY BUDGET AJUSTMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 17-191, the City Commission approved a LAP Agreement which repurposed certain earmarked federal funds, for use to fund cultural resources services for the Bahama Village area, Southard Street and Greene Street, on a reimbursement basis; and

WHEREAS, in Resolution 18-357, the Commission authorized Supplemental Agreement No 1 (SA-1) to the LAP Agreement, removing Amelia and Geraldine Street and adding Petronia Street and Emma Street in response to community input; and

WHEREAS, a cultural resources assessment is a requirement for federally funded projects in historically significant areas, and each step of the FDOT LAP must be approved by FDOT. Accordingly, an RFQ for cultural resources assessment was advertised, bids received and considered at a public meeting, and the selection committee recommended the award of contract to AECOM; and

WHEREAS, the ranking was approved by FDOT, and accordingly City staff recommends approval of a contract with the highest-ranked/most qualified firm, AECOM; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission accepts the ranking, approves the Selection Committee recommendation and hereby awards a contract to AECOM in response to RFQ 18-003 for Cultural Resources Assessment for the Bahama Village Connectivity Project, under FDOT LAP Agreement FM# 440023-1, in an amount not to exceed \$202,491.41 (Task #1 in the amount of \$50,002.00 for a Cultural Resources Assessment; and Task #2 for a Cultural Resources Survey in the amount of \$152,489.41, contingent upon completion of Task #1);

Section 2: That the City Manager is authorized to execute a contract with AECOM for Cultural Resources Assessment, and any related documents, upon advice and consent of the City Attorney.

Section 3: That funding for this project is via FDOT LAP under Local Agency Program (LAP) grant agreement FM# 440023-1, Federal ID: D617-050-B. Contract GO097. City Project II41021804, revenue account 102-000-331-4991 (Internal Improvements/FDOT LAP Grant), expense account 102-4102-541-6300 (Internal Improvements/Streets/Infrastructure), and any necessary budget adjustments are hereby authorized.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
