A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH MARK & ELIZABETH MACLAUGHLIN AS PROPERTY OWNERS, PERMITTING A RELEASE OF LIEN ON 1922 PATTERSON AVENUE UPON PAYMENT BY THE OWNERS OF THE AMOUNT OF \$5,037.75 (\$8,137.75 LESS \$3,100.00 ALREADY PAID); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, a property lien in the total amount of \$162,754.99, resulting from fines accrued in two Code Compliance Files in 2010 - a past due sewer/solid waste account, and Case No. 10-00904 an expired non-transient rental business license, was promulgated upon owners of record, Mark & Elizabeth MacLaughlin in 2010; and

WHEREAS, on April 5, 2019 the property owners submitted a mitigation of lien request, offering \$3,057.68 to settle the lien of \$162,754.99; and

WHEREAS, on May 7, 2019, the City Commission considered the owner's request to mitigate the lien and upon staff recommendation determined to accept 5% of the recorded lien, a total of \$8,137.75 to satisfy the lien; and

WHEREAS, that Mark and Elizabeth MacLaughlin have paid \$3,100.00 to date, which would result in a remaining balance due of \$5,037.75, upon approval of the City Commission; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Manager, upon the advice and consent of the City Attorney, is authorized to enter into an agreement with Mark & Elizabeth MacLaughlin as property owners, to allow the City's release of lien on property located at 1922 Patterson Avenue, upon payment of a mitigated amount of \$8,137.75 (less \$3,100.00 already paid).

Section 2: That the property owner shall pay the remaining reduced lien balance of \$5,037.75 within thirty (30) days of the date of this Resolution as a condition precedent to the release of the lien.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
