A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING BUDGET ADJUSTMENTS IN FY 2018-19 TO FACILITATE THE PURCHASE OF PROPERTY LOCATED AT 3420 NORTHSIDE DRIVE (THE KEY WEST CITIZEN BUILDING), AS APPROVED IN ORDINANCE 19-02, AND APPROVED IN A GENERAL ELECTION ON APRIL 16, 2019 PURSUANT TO SECTION 2-739(2) OF THE CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the purchase of 3420 Northside Drive, described in Ordinance 19-02, and approved in a general election on April 16, 2019, requires budget adjustments in FY 2018-19, so the purchase may be completed on May 14, 2019, or such other date as established by the parties; and

WHEREAS, Section 2-739(2) of the Code of Ordinances requires City Commission approval of budget transfers and increases in excess of \$20,000; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That pursuant to section 2-739(2) of the Code of Ordinances, budget adjustments to facilitate the purchase of 3420 Northside Drive in a total amount of up to \$4,950,000.00 are hereby approved as follows:

- (1) Budget transfer of \$2,525,000.00 from the Key West Bight Fund (Fund 405) to the Infrastructure Surtax Fund (Fund 101).
- (2) That the City Commission declares that Key West Bight Project KB 1501, 907 Caroline Street is eligible for full funding from the Caroline Street Community Redevelopment Fund (Fund 603).
- (3) That the construction appropriation for Phase 1B of the Truman Waterfront Master Plan funding in the amount of \$1,940,000 in FY 2018-19 shall be reprogrammed to FY 2019-20.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
