## Hello Karen,

I am sending you this email on behalf of Kenneth King, Golden Bough Tree Service, regarding a tree that is located at 711 South Street. The tree roots are getting into our lateral sewer pipe at 715 South Street, Alexander Palms Court Guesthouse. The root ball in the pipe blocks anything from flowing through the pipe, causing the toilets to overflow and the sewage to back up into the showers in our guest rooms.

We have to call the plumber to snake the line, and we have to re-home the guests and refund their room rentals for the five rooms in the building that is affected. We have to put the rooms out of service while they are being disinfected, before we can rent them again.

I have attached copies of the plumbing bills and photos of the root ball and where they snake it out of the sewer pipe. I have also attached a copy of the Tree Representation Authorization form that we sent on April 12<sup>th</sup>.
