Dear Ms. Olson,

We are pleased to present this proposal of professional engineering and surveying services for your consideration.

We understand the City would like to move forward with the design of a new floating dock at Kingfish Pier, located at Garrison Bight, which suffered damage from Hurricane Irma. The City has or will submit/obtain FEMA funding for the work. Permitting is already underway as per previous authorization from the City (PO#087361) and therefore it is not a part of this proposal.

Scope of Project:

The proposed improvements consist of a new floating dock, approximately 380 feet in length, with new finger piers, to replace an existing floating pier damaged during hurricane Irma. It is the southernmost pier of Garrison Bight located north of N. Roosevelt Boulevard. The floating dock facility will be similar to those completed at Tarpon Pier, Sailfish Pier, and Dolphin Pier, and will include the same footprint as existing. Pier material will be aluminum framing with ipe decking with an ADA compliant ramp connecting at the same location as existing pier. It is our understanding that the existing upland wood ramp structure will remain. New utility lines will be provided including HDPE piping for water, sewer and fire protection. New G-Cable and all electrical pedestals will be replaced, new data and cable TV and cabinet will be provided. No upland improvements are included; existing upland electrical equipment, utility connections, and sanitary pump-out will remain. All new piles will be epoxy coated tubular steel to match the other recently constructed piers. Boat relocation plan is not required because this is a transient dock.

The City shall provide submerged lands ownership/easement documentation. No lighting or landscaping is included in our scope.

Scope of Services:

<u>Design Phase:</u>

Specific purpose survey of the project area. Engineering design of floating dock system including, structural, electrical, domestic/fire water and sanitary sewer. The floating dock system will be designed for 120 mph wind/wave loads fully occupied, and 150 mph partially occupied. We will provide preparation of construction documents, specifications and construction cost estimates. Our scope includes soil parameters and lateral capacities of piles to be used in design of the new pier structure. Environmental permitting is not included in this proposal. Project Contractor will be required to secure all local building permits. *Bid Phase:*

Prepare bid package including general and supplemental conditions (to be provided by City in electronic format), standard specifications, and bid form. Attend pre-bid meeting with potential contractors, answer bidder questions, prepare addendums if necessary, and review of submitted bids. These services will be provided only to the extent requested by the City.

Construction Phase:

Attend preconstruction meeting, answer Contractor's RFIs, attend weekly meeting via phone conference (if needed), develop and maintain submittal register, review shop drawings, periodic site observation visits (bimonthly at a minimum; for each visit we will prepare a written observation report with photos), review construction progress, final inspection and project certification. Our scope also includes closing all environmental permits. These services will be provided only to the extent requested by the City.

Terms and Conditions:

All terms and conditions shall be per our Agreement for General Engineering Services (dated October 13, 2017). Permit fees are not included and can be paid by Stantec and reimbursed if required.
