

Tree Species: Royal Poinciana (Delonix regia)






















Diameter: 20.3"

Location: 80% (some minor root issues with asphalt and sidewalk)

Species: 100% (on protected tree list)

Condition: 60% (fair, looks like typical older Royal Poinciana tree in Key

West, canopy center primarily over main trunk area.)

Total Average Value = 80%

Value x Diameter = 16.2 replacement caliper inches

The applicant was requested to submit an arborist report documenting any decay in the tree and termite or insect infestation including photos. No evidence was observed during street inspection. Further documentation needed.

Sorry about delay in responding.

The City cut the canopy of that tree since it was deemed a hazardous risk by the police department and community services staff who corresponded via phone with me. City code does require the processing of an emergency after-the-fact permit with a 1- tree replant requirement.

The tree around the corner will have to go to the Tree Commission if you want to remove it. I saw nothing that indicated an immediate threat. Documentation regarding the termites, worms, etc will need to be submitted for the permit review. I recommend getting photos in the canopy and looking top down to see the decay issues clearly.
