Citizen Review Board,

On May, 21, 2019, the Key West Police Department received a complaint from Mr. Lonnie Lehmkuhle through the Citizen Review Board. Mr. Lehmkuhle stated in his complaint that he was terminated from his place of employment (IC Doubles) as a result of six separate visits from various Key West Police Officers to IC Doubles, looking for Mr. Lehmkuhle. Mr. Lehmkuhle felt he was being harassed by the officers, particularly, Officer Cleyton Morris (Primary Officer).

As a result of this complaint, I conducted an inquiry into this incident. I spoke with Officer Morris and Shawna Allen (General Manager of IC Doubles). NOTE: Mr. Lehmkuhle listed Ms. Allen as a witness in his complaint. I also reviewed the report related to this incident (Case #19-3076) and all Body Warn Camera (BWC) videos related to this incident. The following was learned after this inquiry.

On Monday, May 13, 2019, the Key West Police Department received a call from Cassidy Ray in reference to her being harassed by her former roommate, Mr. Lehmkuhle. Officer Morris was dispatched to meet with Ms. Ray at that time. Ms. Ray reported to Officer Morris that she had been receiving several harassing phone calls and text messages from Mr. Lehmkuhle. Ms. Ray told Officer Morris, Mr. Lehmkuhle was asking her to pay him the security deposit from the apartment they previously shared. Ms. Ray said Mr. Lehmkuhle told her that if she did not give him the money, he was going to call the police and "make something up about her." Ms. Ray said the reason she decided to call the police, was she received a text from Mr. Lehmkuhle while she was at work. Ms. Ray works at Fogarty's (227 Duval Street). Ms. Ray said the text message from Mr. Lehmkuhle stated he was watching her from across the street, at the Bull and Whistle Bar (224 Duval Street). In the report, Ms. Ray stated she is afraid of Mr. Lehmkuhle and just wanted him to leave her alone. Officer Morris advised Ms. Ray that he would be completing a report and also requested that she send him copies of the text messages sent by Mr. Lehmkuhle.

Ms. Ray did not know where Mr. Lehmkuhle was living at that time, but provided Officer Morris with Mr. Lehmkuhle's phone number (305-896-7736) and stated that he worked at IC Doubles. Officer Morris said he attempted to locate Mr. Lehmkuhle at IC Doubles several times, but was unable to. Officer Morris eventually spoke with Mr. Lehmkuhle's manager, Shawna Allen. Ms. Allen informed Officer Morris that Mr. Lehmkuhle would not be back to work until Friday, May 17, 2019. Officer Morris said he attempted to call Mr. Lehmkuhle multiple times as well, but received no answer. Officer Morris said the reason he wanted to speak with Mr.

Lehmkuhle was to advise him not to contact Ms. Ray anymore and suggest he take a more appropriate course of action regarding the disagreement over the security deposit.

On May 15, 2019, Officer Victor Arguello was dispatched to IC Doubles at the request of Mr. Lehmkuhle. NOTE: Officer Morris was off duty on May 15th, therefore he was not available to meet Mr. Lehmkuhle when he called. According to the CAD Report, Mr. Lehmkuhle was advised by his manager that officers had come to IC Doubles, looking for him. When Officer Arguello arrived and met with Mr. Lehmkuhle, he informed Mr. Lehmkuhle that Officer Morris was the primary officer regarding this case. Officer Arguello obtained all of Mr. Lehmkuhle's contact information (address and phone number) and told Mr. Lehmkuhle he would provide Officer Morris with the contact information. During the conversation, Mr. Lehmkuhle did request that officers not come to IC Doubles looking for him. Mr. Lehmkuhle requested he be called or contacted at his home address. That same evening, Officer Arguello sent Officer Morris an email, but only provided Mr. Lehmkuhle's phone number, not his address, nor his request not to be contacted at IC Doubles.

Due to the miscommunication, Officer Morris was not aware of Mr. Lehmkuhle's request. On May 18, 2019, Officer Morris went back to IC Doubles in an attempt to locate Mr. Lehmkuhle. Mr. Lehmkuhle was working that evening and met with Officer Morris. Officer Morris advised Mr. Lehmkuhle not to contact Ms. Ray again and also advised him that a report was being completed regarding the incident.

On May 29, 2019, I spoke with Shawna Allen (IC Doubles Manager). I asked Ms. Allen if Mr. Lehmkuhle's termination was the result of officers coming to the bar looking for Mr. Lehmkuhle. Ms. Allen said Mr. Lehmkuhle was terminated because other employees were becoming concerned about what was causing officers to come look for Mr. Lehmkuhle. Ms. Allen mentioned there were other reasons for Mr. Lehmkuhle's termination, but did not provide details.

After completing this inquiry, I have determined Officer Morris' actions were appropriate. Officer Morris was provided with limited contact information for Mr. Lehmkuhle and attempted to call Mr. Lehmkuhle multiple times.
