A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING MULTIRACE, LLC TO CONDUCT THEIR ANNUAL TRIATHLON ON SATURDAY, DECEMBER 7, 2019 THROUGHOUT CITY STREETS; AUTHORIZING CERTAIN STREET CLOSURES THEREOF DURING THE EVENT AND CLOSING ATLANTIC BLVD EXCEPT RESIDENTS DURING THE EVENT FROM 4:00 A.M. TO NOON; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCES PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 5:00 A.M. TO NOON; AUTHORIZING THE CLOSURE OF THE 400 BLOCK OF SOUTHARD STREET FOR THE AWARDS CEREMONY FROM 4:00 P.M. TO 6:00 P.M; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, permission is hereby granted to hold MultiRace, LLC to conduct the annual Triathlon and award ceremony on Saturday December 7, 2019;

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida;

**SECTION 3.** That permission is hereby granted to conduct the MultiRace, LLC Triathlon on the date and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager.

**SECTION 4.** That MultiRace, LLC is hereby granted permission for the closure of certain streets throughout the city for the Triathlon and the awards ceremony on the date and during the hours stated above.

**SECTION 5.** That MultiRace, LLC will be coordinating with the agencies outside of the City of Key West Jurisdiction.

**SECTION 6.** That the MultiRace, LLC is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

**SECTION 7.** That the Event organizers will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

**SECTION 6.** That MultiRace LLC will NOT use paint on the City street and that they will only use a washable chalk to mark the turn around and mile points.

**SECTION 7.** This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
