Description: GrayRobinson provides full-service Legislative and Executive branch advocacy and lobbying for both policy priorities and appropriation projects for the City of Orlando. The following bullet points include successes GrayRobinson has achieved on behalf of the City of Orlando through its representation:

- Secured \$100,000 for Rapid DNA project that will allow the Orlando Police Department and surrounding jurisdictions to more quickly test rape kits addressing both the backlog of untested kits and expediting future investigations. (2019)
- Defeated legislation aimed at restructuring Metropolitan Planning Organizations. (2018)
- Defeated legislation targeting the structure, allowable expenditures, reporting requirements and length of existence of Community Redevelopment Agencies. (2018)
- Helped pass a public record exemption bill related to police body cameras when the footage captured is exempt from public record disclosure. (2016)
- Lobbied to restore the Government Event Tax Exemption without a sunset date. This little known but valuable tax exemption was automatically repealed from statutes in 2009. It allowed counties and/or municipalities to conduct events at their public venues without charging a sales tax on admissions. This was put in place to avoid the "robbing Peter to pay Paul" scenario of a local government collecting taxes on its own event, only to turn it over to the state. Many communities, including the City of Orlando, relied on these events for revenue to support their local venues. (2016)
- Secured passage of legislation that clarifies that the clerk of the courts cannot collect administrative costs on Uniform Traffic Citations (UTCs). This guarantees that local governments will receive their full statutory allotment of a paid citation. (2016)
- Worked with stakeholders to secure \$20 million for the University of Central Florida's Downtown Campus. Additionally, we defeated an effort to preempt local governments from regulating the use of polystyrene products on public lands.

- Secured amendment to clarify that, in instances where a municipality is the entity providing the required local financial
 incentive for an economic development project under the QTI program, it is the municipality, and not the County in which
 it resides, that handles all coordination with OTTED and provides the required wage-scale calculations. (2013)
- Served as part of the lead lobbying group to enact legislation that would allow counties and municipalities to use red light camera technology in the enforcement of red light violations. This was an eight-year battle culminating in the passage of means to ensure further safety on Florida's roads. While there were other lobbyists working on this issue, our Team participated in and often led the meetings that developed the final form of this legislation. (2010)

The following bullet points include successes GrayRobinson has achieved on behalf of the City of West Palm Beach through its representation:



- Secured an amendment to a claim bill to rewrite the entire whereas clauses section to comply with the City's settlement agreement. (2019)
- Secured passage of a local bill pertaining to the City's firefighter pension program. (2019)
- Secured \$400,000 for road improvements to the Rosemary Corridor. (2018)

The following list represents further outstanding accomplishments achieved in the delivery of services similar in scope to those requested by the City, including a list of successes we have achieved on behalf of the City of Key West throughout our representation:

CITY OF KEY WEST

- At the direction of the City, the Team successfully advocated for \$6 million in Florida Keys Stewardship Act funding for water quality improvements and \$33 million in Florida Forever funding for Areas of Critical State Concern. All local governments within Monroe County will receive their portion of funding via inter-local agreements with Monroe County. (2019)
- Successfully secured exemption for the Florida Keys Area of Critical State Concern from legislation that would have preempted the affordable housing efforts in the Florida Keys and handicapped their planning, zoning, and building departments. (2019)
- Secured two-hour meeting with Division of Emergency Management Director Moskowitz and senior staff to rectify Keys Electric reimbursement issues stemming from Hurricane Irma. (2019)
- Successfully lobbied the Governor's office to help secure a veto of House Bill 771, which among other provisions would have preempted a local government's authority to prohibit the use of single-use plastic straws. (2019)
- Successfully lobbied to defeat a Senate proposal that would have barred Visit Florida from promoting communities that have banned certain sunscreens, such as the City of Key West. (2019)
- Successfully amended the tree trimming preemption bill to exempt the delegated authority for mangrove protection and worked to defeat the bill after the Senate would not concur with the House language. (2018)
- Successfully lobbied the Constitutional Revision Commission to defeat Proposal 95 (preemption on the local regulation of commerce, trade, and labor). (2018)



- Successfully helped defeat Senate Bill 1828, which would have handicapped the City's emergency operations and increased liability to the City and Keys Electric. (2018)
- Successfully argued that based on geography and other unique factors, the Legislature should disregard the Supreme
 Court in a recommendation that the Legislature decertify a Monroe County Judge. Doing so would have left one of
 Monroe County's courthouses with no county judge since the two outside Key West only have one county judge each. The
 impact on the Key West courthouse dockets and additional travel in and out of the City was a huge concern. The
 decertification was eliminated in both the House and Senate Bills. (2018)
- Helped secure passage of the Florida Keys Stewardship Act. The Act adds Key West to the list of eligible areas for which Everglades restoration bonds may be issued and expands the range of uses for the funds. In addition, the bill allocates a minimum of \$5 million annually to the Florida Keys Area of Critical State Concern beginning FY 2016-2017 through FY 2026-2027. The bill also provides a specific appropriation of \$5 million in FY 2016-2017 to be distributed in accordance with the existing inter-local agreement for various water purposes and to enhance water supply or for land acquisition. (2015)
- Helped secure \$50 million for the Florida Keys Wastewater Treatment Plant. (2012)
- Lobbied for the passage and approval of legislation that designated the Schooner Western Union, currently harbored in Key West, as the official Flagship of the State of Florida. (2008)
- Secured \$1 million for the City of Key West's Vandenberg Project. The City of Key West sought state funding to purchase and sink the USS Vandenberg off the coast of Key West. This sinking has already led to increased tourism to the area by both the recreational fishing and diving industries. (2008)

CITY OF CLERMONT

- Secured \$450,000 for equipping the City's world-famous bike trail network with Wi-Fi coverage to enhance public safety and tourism marketability. (2018)
- Secured \$500,000 for a priority alternative water supply project. (2014)

CITY OF FORT MYERS

 former inmates who have settled in the City. The program is designed to transition recovering offenders into full-time

 Successfully worked to defeat the vacation rental preemption bill after proponents refused to add "party house" language vital to the interests of the City. (2018)

4. IMPLEMENTATION OF SCOPE OF SERVICES

a. Identify the consultant's proposed methods and an estimate of time necessary for specific activities in the pursuit of State funding opportunities.

Scope of Services

Working in consultation with the City Manager and/or elected officials, the following are areas of responsibility of the State Government Relations firm:

FUNDING OPPORTUNITIES

1. Work closely with the CITY to obtain all necessary project information.

GrayRobinson will continue its representation of the City with a joint legislative workshop to develop a legislative agenda for the upcoming Session. During this workshop, the Team will obtain all necessary project information. For the City, and for us, the agenda must provide clear articulation of goals and expectations which, when combined with the City's scope of services, will serve as a roadmap for our representation. The time necessary for this would be time spent at the workshop and subsequent communications, which we estimate would take about three hours.

2. Secure State funding for the CITY including proactive identification of specific funding opportunities.

Our strategy for securing state funding for the City on appropriations matters would address projects requested by the City and focus on important advocacy for the City's funding priorities to be included within the Executive branch agencies' budget requests as well as the Governor's proposed budget (submitted to the Legislature prior to each Session). From there, our focus will shift to the leadership of both the House and Senate, beginning with the Speaker and the President. We will spend considerable time and effort educating the respective budget chairs of each chamber along with their staff to ensure they know and fully understand the importance of the City's appropriations requests. Lastly, we will educate the chairs and members of the appropriations subcommittees that have jurisdiction over the specific budget requests. All of our efforts to secure funds for the City will be done in conjunction with its local delegation, just as we have done for the past twelve years.

These steps are important to achieving success in the appropriations process, and GrayRobinson has critical relationships in both the Executive and Legislative branches of Florida's state government that will benefit the City and its priorities. If it is the continued direction of the City, the Team will continue to work collaboratively with Florida Keys stakeholder groups to jointly advocate for continued Florida Keys Stewardship Act funding. This strategy and our involvement in it has led to tens of millions of dollars for the Florida Keys, which has facilitated the enhancement of wastewater facilities, water quality improvements, canal restoration, coral reef restoration, and other projects important to Key West. In addition to our diligence in securing state funding, we will be proactive in identifying funding opportunities throughout Session. As this is an ongoing activity during Session, it is challenging to define an estimate of the time necessary to complete. It will depend on the City's goals and priorities, and be determined and agreed upon after our Agenda is created.

3. Monitor State legislation and programs of State agencies to identify new funding sources.

Throughout our representation, we will monitor all legislative bill filings, appropriations requests, and amendment filings. We subscribe to LobbyTools as our primary bill tracking and monitoring system. LobbyTools enables us to efficiently research bills, PCBs, statutes, legislators, committees, calendars for executive agencies and licensing boards, Florida and national news, press releases, and other essential information pertaining to the City. We modify the system to generate customized reports specific to the City in order to provide the most targeted, up-to-date and cost-effective information



available. We also monitor all agency rulemaking through a state tracking system. Additionally, we enjoy strong relationships with staff and various members of Florida's state agencies and we will utilize these relationships to assist in monitoring all activity relevant to the City. We will continue to provide the City with weekly bill reports as we have done in previous years. This also is an ongoing activity on which we spend time each day during Session - approximately one hour per day.

4. Prioritize funding opportunities according to their potential as funding sources.

GrayRobinson will advise the City of potential funding opportunities, and prioritize opportunities according to their potential as funding sources based on our knowledge of the process and our experience. Given our experience in this, time spent prioritizing will be minimal and no more than two hours per week.

5. Develop timelines, giving dates when certain activities should begin and when materials should be compiled to meet State guidelines and deadlines.

We have found that a timeline of benchmarks helps clients and our Team be better positioned for legislative success. Below are recommendations for a timeline of activities to be accomplished leading up to, during, and following Session. Given the work we have put in to determine the timeline up front, there is no time necessary for this task.

- From September 1 through October 31, GrayRobinson will work with the City to foster an in-depth understanding of the City's evolving needs and any new issues for this upcoming Session, as well as the strategy, tactics, and messaging for these, with initial meetings with the City's leadership, directors, and designated staff taking place during this period.
- Following these meetings, we propose the development of a written legislative agenda, including the refinement of proposed statutory or appropriations-based changes from October 15 through November 30. This strategy would include supporting the plan and execution of a successful "Day at the Capitol" for the City to both raise its profile in the Florida Legislature and garner support for its issues. This "Day at the Capitol" can be scheduled during the committee weeks in November and December or during the first month of Session (January). The plan would also include our collaborative involvement in Florida Keys Day, both as a long-standing and active sponsor, and as the City's liaison/guide during the trip.
- Concurrently identify champions and supporters in the Legislature of each of these goals, as well as avenues to enact these changes. In some cases, this may be through the filing of individual policy bills by House and Senate Members and moving them through the committee process. In those cases, having this strategy in place and beginning to take action would ideally be accomplished during committee weeks sometime from **October 1** through **November 30**.
- After the legislative Session concludes, we will ensure appropriate follow-through on bills impacting the City and strategies/issues for the 2021 Legislative Session by April 10, 2020. We will provide the City with a full bill report and will visit Key West in person as we have in previous years.

6. Act as a representative of the CITY and its projects.

In our representation of the City of Key West, we will act as a representative of the City in Tallahassee on an ongoing basis, as we have done for the last twelve years. Our representation of the City is not something we take lightly and we will continue to be fierce and ethical advocates of the City and take on its projects as our own.



7. Coordinate with the State delegation in gaining support for State funding for the CITY, assist in drafting appropriate correspondence, schedule briefings and meetings.

GrayRobinson goes to great lengths to build long and lasting relationships with key decision makers. With 14 offices throughout the state and an office in Washington, DC, we know legislators, agency heads, key staff and other elected officials in their home towns, we support their causes, and we are their neighbors and friends. One cannot effectively advocate without the ability to interact and work with legislators, members of the Governor's staff and with the heads of the state's many agencies in many different venues and circumstances. Some of GrayRobinson's specific relationships are described below and all of these relationships will be used to gain support of State funding for the City. We will draft appropriate correspondence and schedule briefings and meetings as needed to further garner support. The time spent on this would depend on how much effort is needed throughout Session. It would be an ongoing effort with regular reports and open communication with the City.

House and Senate Leadership

Our Team has working relationships with the leadership in both the House and Senate. Speaker JOSE OLIVA served with Team member Dean Cannon in the House and has a great relationship with our Team. Additionally, Team member Joseph Salzverg worked on the Speaker's special-election to the House in 2011. Our Team also has developed excellent relationships with the Speaker's lieutenants. In the Senate, it is much the same. Senate President BILL GALVANO has worked with our Team since his days in the Florida House, including serving with Dean Cannon. We know his priorities (higher education and transit) and know his style of leadership.

As well, we work to establish relationships not just with the current leaders, but with those to come. In the House, we were early supporters of future speakers CHRIS SPROWLS, PAUL RENNER and DANIEL PEREZ, and our Team has been working closely with 2020-22 Senate President-designate WILTON SIMPSON since his days at the Tampa Chamber. Thus, whether it is the current Speaker and President, or the incoming presiding officers, we have worked diligently to forge these relationships based on common interests, trust and reliability.

Perhaps the best way to establish the trust and confidence we are asking the City to place in our Team is to point to times when others, similarly situated, placed their trust and confidence in members of GrayRobinson's lobbying Team:

- TEAM MEMBER KIM MCDOUGAL, PH.D. served as Chief of Staff to Florida Governor Rick Scott where she was responsible for directly serving and advising the Governor on issues pertaining to 100,000 plus Executive Branch employees and administering an \$83 billion state budget. Kim also worked for Governor Bush in several roles within the Executive Office of the Governor, including as the policy coordinator for education in the Office of Planning and Budget.

8. Identify and meet with key State agencies, officers of the State government and members of the State legislator related to specific funding sources, propose and implement lobbying and advocacy strategies for gaining their support for CITY projects.

We commit to identifying and coordinating relevant appointments and meetings with key State agencies, officers of the State government and members of the Florida Legislature related to specific funding sources, and will propose and implement lobbying and advocacy strategies for gaining their support for City projects. In addition to the capabilities of a Team that collectively has served and advocated under five Governors, we maintain excellent working relationships with all of the agency heads, and strong relationships with the Cabinet.

We will also work with the City to identify opportunities for its leadership to not only meet with state officials and legislators, but to speak on matters affecting Key West, so that City leadership continues to be regarded as thought-leaders on issues that impact local government.



9. Establish and maintain liaisons with key State agencies, officers and elected officials to gain support for CITY projects.

GrayRobinson is well known and respected in both the Legislative and Executive branches, including the state agencies, and has a broad network of personal and professional relationships with policymakers as well as with their staffs. The GrayRobinson Team has solid working relationships with Department of Economic Opportunity (DEO), Department of Environmental Protection (DEP), Department of Transportation (FDOT), Division of Emergency Management (DEM), Department of Business and Professional Regulation (DBPR), and Florida Fish and Wildlife Conservation Commission (FWC). These are relationships built on trust and respect based on years of honest and forthright interactions. We will engage our relationships with key State agencies, officers and elected officials to gain support for City projects. This is an ongoing activity for which it is hard to determine up front how much time will be spent during our representation of the City. However, we will work and communicate closely with our key contacts so resources can be monitored and, when possible, time determined.

Agencies of the State of Florida

Relationships with the agencies of the State of Florida are important to advancing the City's priorities as well. Specific examples of our relationships here include:

- City of Key West Team Lead JASON UNGER enjoys strong relationships with the Florida Department of
 Transportation and the Division of Emergency Management. His relationship with FDOT has included working with
 Secretary Kevin J. Thibault on the Cow Key Bridge issue and scheduling productive meetings with him as well as his key
 staff and City of Key West representatives. He also has a strong relationship with the Department of Revenue.
- City of Key West Team member CHRIS CARMODY's relationship with the Department of Economic Opportunity and Enterprise Florida allows him to provide strong support to county grants;
- As a former Speaker, City of Key West Team member DEAN CANNON enjoys relationships with most of the agencies, but also has specific relationships with Florida Department of Transportation, Department of Economic Opportunity, Department of Environmental Protection, and Enterprise Florida (serves on the Board of Directors);
- As the Chief of Staff to former Governor Scott, City of Key West Team member KIM MCDOUGAL, PH.D. enjoys great relationships with, among others, the Department of Juvenile Justice, Department of Education, Division of Emergency Management and Department of Corrections; and
- City of Key West Team member JOSEPH SALZVERG regularly advocates for his clients on issues related to home rule, transit, affordable housing, professional licensure, vessels and waterways, and emergency operations. As such, he has extensive experience working with DBPR, DEM, DEO, DEP, FDOT, and FWC.

10. If requested, prepare State grant applications.

Our Team has experience securing timely approval of grant applications and reviewing documents related to these funding request applications. The time spent on grant applications would depend on the volume we are asked to prepare. 12. As requested or necessary, arrange meetings between State agencies and members of the Executive branch, Legislators and/or legislative staff with the Mayor, City Commissioners and the City Manager to promote the funding of CITY projects or to discuss legislative issues effecting the CITY.

We commit to identifying and arranging meetings between State agencies and members of the Executive branch, Legislators and/or legislative staff with the Mayor, City Commissioners and the City Manager to promote the funding of City projects or to discuss legislative issues effecting the City. In addition to the capabilities of a Team that collectively has served and advocated under five Governors, we maintain excellent working relationships with all of the agency heads in the DeSantis administration, and have strong relationships with members of the Cabinet. In 2019, at the request of the City, we secured a meeting with FDOT Secretary Kevin Thibault to discuss the Cow Key Bridge and also secured a meeting with DEM Director Jared Moskowitz to discuss Hurricane Irma reimbursements. We will continue to secure similar meetings moving forward as requested. The time spent to accomplish this will depend on the need to arrange such meetings based on the priorities of the City.

13. Identify agencies or other local governments which may be competing for specific grants or appropriations and assist in aligning support for CITY Projects.

We are well equipped to identify agencies or other local governments which may be competing for specific grants or appropriations and will assist in aligning support for City Projects. Our relationships are far-reaching, enabling us to work well with other lobbyists whose clients share a common goal. As an example of aligning support with other interested parties, we have recently worked collaboratively with Florida Keys stakeholder groups to jointly advocate for continued Florida Keys Stewardship Act funding. If this is a continued priority for the City, we will focus on this for 2020 and beyond. This would be an ongoing effort and an estimate of time would depend on whether there are other agencies or local governments we would approach about aligning efforts for City projects.



14. Provide quarterly reports to the City Manager or designee demonstrating the progress of the individual or firm toward securing funding for CITY projects. The report shall provide enough information as needed in order for the Mayor, City Commission, City Manager and staff to support any lobbying strategies.

GrayRobinson will provide regular written briefing reports at the end of each week during committee weeks and Legislative Sessions to the City Manager or designee. We are prepared to provide reports more frequently as requested and will tailor them specifically to the needs and requests of the City. The Team will work diligently to provide the City with an update on its legislative priorities immediately following Session. Although the City will have been kept aware of developments throughout Session, the Team also will provide a detailed written report as soon as possible following Session which will include specific legislation and new requirements affecting the City. Status on the reports will be communicated regularly so the City will know when to expect delivery. The City also will be invited to attend "Session Wrap-Up" events we host across the state. The time to prepare each report is estimated at one hour per report.

15. Appear before the City Commission as requested to report on fund development activities, approximately two (2) times annually. Appearances will be scheduled in advance at the request of the Mayor and City Commission.

GrayRobinson commits to appear before the City Commission to report on fund development activities, approximately two times annually. Our goal is to provide exemplary legislative services. Team Lead Jason Unger will be on call and available for consultation, advice, and other services as requested by leadership and staff. The time spent on this effort will be the time each meeting requires, which we estimate to be no longer than two hours per meeting.

MONITORING

1. Review on a continuing basis all existing and proposed State of Florida policies and legislation effecting the CITY. Throughout our representation, we will constantly monitor all legislative bill filings, appropriations requests, and amendment filings. As mentioned previously, we subscribe to LobbyTools and use this as our primary bill tracking and monitoring system. We will modify the system to generate customized reports specific to the City in order to provide the most targeted, efficient, up-to-date information available. We will provide these reports in writing and will communicate important items orally as needed and when it is timely, including the benefits and any adverse impacts of the proposed legislation. This is an ongoing activity that would take about fifteen to thirty minutes each day.

 Work closely with the Mayor, City Commission, City Manager, Assistant City Manager and senior staff in the coordination and development of the City's legislative program for both long and short-term perspectives, as well as legislative priorities.

We are prepared to continue to work closely with the Mayor, City Commission, City Manager, Assistant City Manager and senior staff in the coordination and development of the City's legislative program for both long and short-term perspectives, as well as legislative priorities. As mentioned previously, we will work on developing the legislative agenda at the outset of the engagement and will be prepared to execute throughout Session, making adjustments along the way as needed. This would be ongoing and would require about two hours each week.



3. Work closely with the Mayor, City Commission, City Manager and senior staff to develop special or general legislation in keeping with, or supportive of, the City's adopted legislative program.

To help ensure an even more successful relationship, we propose an approach that includes frequent and ongoing communication with City leadership, including attendance at all appropriate meetings and any other meetings pertaining to the City's legislative agenda. We will work with City leadership to ensure we understand both the immediate and long-term goals that are vital to the advancement of the City's strategic plan. As mentioned previously, the Team will schedule a legislative workshop to develop a legislative agenda for the upcoming Session. For the City, and for us, the agenda should provide clear articulation of goals and expectations which when combined with the City's scope of services, will serve as a roadmap in our representation. The moment these agendas and strategies are set, our Team will begin advocating on behalf of the City and will assist in developing special or general legislation to support this strategic plan and legislative program. This would be an ongoing activity. Time spent will depend on how much development of special or general legislation will be needed to meet the City's goals. We estimate it would be about three to five hours per week.

BILL TRACKING

1. Obtain and monitor all bills, resolutions, files, journals, histories, etc. that may have an impact on legislative or regulatory interests of the CITY.

GrayRobinson will obtain and monitor all bills, resolutions, files, journals, histories, etc., that may have an impact on legislative or regulatory interests of the City. Throughout our representation, we will constantly monitor all legislative bill filings, appropriations requests, and amendment filings. As mentioned previously, we subscribe to LobbyTools and use this as our primary bill tracking and monitoring system. LobbyTools enables us to research bills, PCBs, statutes, legislators, committees, calendars for executive agencies and licensing boards, Florida and national news, press releases, and other essential information pertaining to the City. We also monitor agency rulemaking through a state tracking system. Additionally, we enjoy strong relationships with staff and various members of Florida's state agencies. We will utilize these relationships to assist in monitoring all activity relevant to the City. LobbyTools allows us to spend minimal time on this as the work is done for us by the system. Time spent would be about fifteen to thirty minutes each day.

2. As copies of any bills and amendments are determined to have an impact on legislative and regulatory interests of the CITY, copies shall be forwarded to the Mayor, City, Commission and City Manager.

GrayRobinson is prepared to notify the City immediately of any bills or amendments that are determined to have an impact on legislative and regulatory interests of the City. In addition, we will modify the LobbyTools system to generate customized reports specific to the City in order to provide the most targeted, up-to-date information available. The time required for this is estimated at 5 hours per week during committee weeks and 10 hours per week during Session.



5. FEES

GrayRobinson proposes a lump sum price of \$72,000 annually for performing all of the work described in the Request for Proposal. This is the same fee we have charged the City since 2009. We do not anticipate any additional costs for this proposal.
