- Passing multiple amendments, on behalf of Monroe County, to the Citizens Property Insurance statute to protect Keys policyholders from punitive legislative measures.
- Passing reforms to the State Land Purchasing program to allow the Division of State Lands to prioritize the purchase of Monroe County parcels to lessen the negative effect of "buildout" created under the Rate of Growth Ordinance.

<u>Karl N. Rasmussen – Meenan P.A.</u>

Robert has been active in local and statewide campaigns, most recently serving as Finance Director to Tom Gallagher's 1994 Gubernatorial Campaign and Finance Director & Treasurer to Gallagher's campaign for State Education Commissioner.

Section 4. Implementation of Scope of Services

We Know Tallahassee and The Florida Keys!

Meenan P.A. and Capitol Group, Inc.'s representation of the City of Key West will provide a unique opportunity to advocate on behalf of Florida's most iconic city, and international destination. Although our team currently represents one municipality, the City of Key West would be the only City government on our client lists. We believe this is a significant opportunity for the City to have professionals with the experience and success of Meenan P.A. and Capitol Group, Inc. to exclusively represent its interest in Tallahassee.

When we push for funding, Key West will not be in competition with other cities' budget requests. You will be our ONLY priority.

We have reviewed the entire scope of services, including "Funding Opportunities," "Monitoring" and "Bill Tracking" and commit to providing all services for each item identified.

Meenan PA and Capital Group will identify state funding opportunities for various City of Key West needs. We will work on numerous agencies such as the Departments of Economic Opportunity, Transportation, Environmental Protection, Emergency Management and others. In addition, we will work with lobbyists from other cities and counties, including a focus on other Keys cities legislative teams, to obtain maximum funding from the Florida Keys Stewardship Act, as well as supporting policy legislation that is beneficial to the Florida Keys Community. We will also coordinate with those teams to fight legislation that attacks home rule, or is detrimental to Key West, or to Florida Keys communities. We will consult with key members of the Governors' Office of Policy and Budget to determine what priorities the Governor will be pursuing each year to identify funding sources, and also to suggest priorities to be included in the Governors' budget that will benefit Key West. We will draft a report on each agency we meet with, outlining any opportunities that develop as a result of our outreach.

We will provide all written quarterly reports, and will draft periodic timely reports as important developments take place, to submit to City staff, and as directed, to the Mayor and City Commissioners.

We will review all filed bills to determine any impact on the City, and will forward bills which we believe could impact the City to Staff for further review and comment. We will review every amendment on bills of interest filed, both in Committee and on the Floor, and will forward those to City Staff. We will insert all tracked bills onto a Lobbytools list, and provide that electronic list to the City weekly during legislative session, and also during committee weeks that occur outside of Session. Finally, we will provide a weekly written report on key priorities and other action that occurred that week and remit to the City to keep you abreast of developments throughout



Session. Importantly, we will call our key City Staff Liaison regularly throughout the legislative session as new issues arise, such as amendments that we need input and comment on.

We also understand the "siege" that local governments have been under to preempt local control of communities. We do not have any clients supporting the erosion of Home Rule. Key West has very unique environmental challenges, none greater than the protection of the coral reefs. Any preemption to proposed protection of the reefs should be fought or carved out of such legislation. The professionals at Meenan P.A. and Capitol Group, Inc. will also work with the Executive branch to urge the legislature to protect the Florida Keys Coral Reef tract.

Meenan P.A. and Capitol Group, Inc.'s core philosophy is one of integrity. Section 5. Fees

This fee will not include any work for litigation. The professionals will seek reimbursement on regular expenses, such as photocopying, WestLaw research, conference calls, postage, travel costs for lodging, meals, rental car and airfare, and any other expenses that may arise related to the scope of work if approved by the City of Key West.

CITY OF KEY WEST INDEMNIFICATION FORM

To the fullest extent permitted by law, the CONTRACTOR expressly agrees to indemnify and hold harmless the City of Key West, their officers, directors, agents and employees (herein called the "indemnitees") from liabilities, damages, losses and costs, including but not limited to, reasonable attorney's fees and court costs, such legal expenses to include costs incurred in establishing the indemnification and other rights agreed to in this Paragraph, to persons or property, to the extent caused by the negligence, recklessness, or intentional wrongful misconduct of the CONTRACTOR. its Subcontractors or persons employed or utilized by them in the performance of the Contract. Claims by indemnifices for indemnification shall be limited to the amount of CONTRACTOR's insurance or \$1 million per occurrence, whichever is greater. The parties acknowledge that the amount of the indemnity required hereunder bears a reasonable commercial relationship to the Contract and it is part of the project specifications or the bid documents, if any,

The indemnification obligations under the Contract shall not be restricted in any way by any limitation on the amount or type of damages, compensation, or benefits payable by or for the CONTRACTOR under Workers' Compensation acts, disability benefits acts, or other employee benefits acts, and shall extend to and include any actions brought by or in the name of any employee of the CONTRACTOR or of any third party to whom CONTRACTOR may subcontract a part or all of the Work. This indemnification shall continue beyond the date of completion of the work.
