This Work Order is an authorization to proceed with the work described herein under the PAVEMENT MARKINGS, STRIPING, & ROADWAY SIGNSAGE 2017 between the City of Key West and <u>Charlie Toppino and Sons, (CTS)</u>. All work shall be executed under the provisions of the contract except as adjusted within this work order.

### The Scope of Work is described as follows:

# Provide all material, labor and equipment for the installation of roadway striping in Area 1 (see contract map) as discussed in the field between the contractor and the City.

### CONTRACTOR'S DECLARATION AND UNDERSTANDING

The contractor declares that he has carefully examined the Contract Documents, including this Work Order, that he has personally inspected the potential sites and the overall project area in general, that he has satisfied himself as to the quantities that may be involved, including materials and equipment, and conditions of work that may be involved, including the fact that the description of the quantities of work and materials, as included herein, is brief and is intended only to indicate that general nature of the work and to identify the said quantities with the detailed requirements of the Contract Documents, and that this Work Order is made according to the provisions and under the terms of the PAVEMENT MARKINGS, STRIPING, & ROADWAY SIGNAGE 2017 Contract Documents between the City of Key West and <u>CTS</u> dated <u>February, 2017</u> which this Work Order is hereby made a part of.

### START OF CONSTRUCTION AND CONTRACT COMPLETION TIME

The bidder further agrees to begin work as directed by city staff and to complete the construction, in all respects for this work order, within 60 working days.

### UNIT PRICE ITEMS

Charlie Toppino and Sons further proposes to accept as full payment for the work proposed herein the amounts computed under the provisions of the Contract Documents and based on the following unit price amounts, it being expressly understood that the unit prices are independent of the exact quantities involved. The amount shall be shown in both words and figures. In case of a discrepancy, the amount shown in words shall govern.

Unit prices for items already established in the PAVEMENT MARKINGS, STRIPING, & ROADWAY SIGNAGE 2017 shall be identical to those provided in this Work Order.

Payment for materials and equipment authorized by the ENGINEER in a written Work Order but not listed in the Proposal will be provided at the suppliers' invoice plus shipping plus 25 % for overhead and profit.
