On Wednesday, October 23, 2019 at 10:35 PM, I was conducting an area check of the Key Plaza shopping center at 2900 North Roosevelt Boulevard when I observed Angelena Essex, whom I knew from previous law enforcement encounters, sitting under a tree near the Mattress Firm store.

Angelena was surrounded by all her belongings. I asked her if she had been trespassed from Key Plaza. She told me she hadn't. I ran her Michigan Driver's License on my in-car computer. Our report management software showed Officer Marrero issued Angelena a trespass warning and camping warning at this same location on October 18, 2019 at 8:55 AM.

I told Angelena she was under arrest. I grabbed her wrists and began to maneuver her arms behind her back. She began tensing her arms and yelling about her wallet. I gave Angelena several verbal commands to stop tensing and to keep her hands behind her back. Angelena continued tensing her arms and began swinging away from me. I swung her to the right; escorting her to the ground to better gain control of her. Angelena made multiple attempts to sit up and continuously hid her hands under her person; preventing us from getting handcuffs on her. Angelena ignored orders to lay on her stomach by coming to her knees and twisting around. Angelena even ignored commands after I displayed my taser. With Officer Litton's assistance I was able to get a handcuff on her left wrist. Angelena continued attempting to sit up. I took the cartridge out of my Taser, which I placed beside me, and drive stunned her in her upper left back. Angelena reacted to the pain by loosening her other arm enough for us to get the handcuff on her wrist.

Angelena had an abrasion around the outside of her left eye. I photographed the abrasion and submitted it to evidence.com. Key West Rescue responded. Angelena refused treatment and didn't complain of any other injuries.

Officer Morris transported Angelena to the Monroe County Detention Center in the KWPD prisoner transport van. I followed behind in my patrol car. I turned Angelena over to the detention deputies without incident.

I submitted Angelena's bags to property at the Key West Police Department for safekeeping.

Angelena did violate F.S.S. 810.09(1)(a)(1), TRESPASS-ON PROPERTY OTHER THAN STRUCTURE OR CONVEYANCE by willfully entering in and remaining on the property of Key Plaza. Notice not to enter on the property was given by actual communication from Officer Marrero on October 18, 2019, after he observed her camping and loitering.

Angelena did also violate F.S.S. 843.02, RESISTING-WITHOUT VIOLENCE by disobeying my verbal commands to keep her hands behind her back and to stop tensing, and by tensing, pulling away, and attempting to sit up while I was trying to detain her. At the time I was a Key West Police Officer in the legal execution of my duties. Angelena should have known I was a Key West Police Officer as I was dressed in my Class B uniform. Angelena also knew me from previous law enforcement encounters.

I activated my KWPD issued bodycam during this call.
