Subj: 2019-12 KWBB Schooner Western Union Restoration Progress Report

The Schooner Western Union has returned to the Keys and she is safely berthed at the 3D boatyard on Stock Island.

- A. The Schooner's keel and hull are secure and relatively sound. There are a few minor leaks but they are easily handled by the automated pumps on board the Schooner.
- B. We are still waiting for the State of Florida to issue the final disbursement of \$125,000 from our original \$500,000 State grant. Due to lengthy State processes, we now expect to receive the check in the next couple of weeks.
- C. Initial contacts have been made with local Coast Guard inspectors.
- D. We have determined that, with the vessel's substantially reduced weight, due to the removal of the masts, rigging, ballast lead, etc., we will be able to haul out the Schooner at Robbie's Marina. This haulout will facilitate the bottom repairs that remain to be completed. Management at Robbie's has said they will haul the schooner and allow her to be worked at Robbies for no charge.
- E. We are developing plans for this next stage of the restoration and meeting with potential shipwrights.
- F. We are also researching additional opportunities for grants and other support which we may be more likely with the Schooner in her home port.
