A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF A WILO SUBMERSIBLE PUMP AND ROCKWELL AUTOMATION VFD FROM PSI TECHNOLOGIES, INC. ON A BRAND NAME, SOLE SOURCE, AND IN THE BEST INTERESTS OF THE CITY, PURSUANT TO SECTION 2-844, 2-797(1) AND 2-797(4)(b) OF THE CODE OF ORDINANCES, IN A TOTAL AMOUNT NOT TO EXCEED \$331,607.14; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-796 of the Code of Ordinances requires competitive bidding for purchases or services in excess of \$50,000.00; and

WHEREAS, the purchase of Wilo pumps pursuant to the brand name specifications provisions of Key West Code of Ordinances section 2-844 is permitted; and

WHEREAS, City contractors Black and Veatch worked with OMI staff and determined that Wilo pumps, available exclusively through PSI Technologies, in this area, are the best choice for effluent motor design for the City's purposes; and WHEREAS, purchasing the Rockwell Automation VFD together with the pump from PSI Technologies is in the best interests of the City, so that the installer can work directly with the provider of both components for installation and warranty purposes; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

<u>Section 1</u>: That the purchase of one Wilo Submersible Pump and Rockwell Automation Variable Frequency Drive (VFD) from PSI Technologies, Inc. is hereby approved on a brand name basis, pursuant to Code of Ordinances section 2-844, sole source basis, pursuant to Code of Ordinances Section 2-797(1), and Section 2-797(4)(b), best interests of the City, in an amount not to exceed \$331,607.14.

<u>Section 2</u>: That this purchase is funded though budget account Sewer/WWTP/CIP project Number SE35041902 fund 401-3504-535-6500, project name Third Effluent Pump. <u>Section 3</u>: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
