A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "INTERLOCAL AGREEMENT FOR ENGINEERING DESIGN, PERMITTING CONSTRUCTION SERVICES FOR OLD TOWN ROADWAY IMPROVEMENTS PHASE 1" BETWEEN MONROE COUNTY AND THE CITY OF KEY WEST; AUTHORIZING ANY NECESSARY ADJUSTMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, certain portions of Duval and Whitehead

Streets are Monroe County maintained roads within Key West
city limits, while the City of Key West is responsible for
sidewalks, curb ramps, traffic control and utilities
operated within this right of way; and

WHEREAS, the City and County want to coordinate work to minimize traffic impacts and share costs, and accordingly, staff recommends approval of an Interlocal Agreement, which would allow the County to reimburse the City for additional design and construction costs for certain portions (see 'AREA 2 Attachment A' attached) of "Old Town Road Improvements Phase 1"; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION
OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached "Interlocal Agreement for Engineering Design, Permitting and Construction Services for Old Town Road Improvements Phase 1" between Monroe County and the City of Key West is hereby approved.

Section 2: That funds for design and survey services will be from Account No. 102-4102-541-6300, Project Code II41021902, in a total amount of \$124,61.00, with the county to reimburse the City \$49,917.51 for their portion of the project, and any necessary budget adjustments are hereby authorized. (Permitting and construction services costs will be determined and reimbursed in part by the County at a later date as necessary.)

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
