A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER UNDER THE CITY'S GENERAL UTILITIES SERVICES CONTRACT WITH D.N. HIGGINS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$196,660.00 FOR SEAWALL RAILING REPLACEMENT AT CITY MARINA; AUTHORIZING NECESSARY BUDGET ADJUSTMENTS AND TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 15-292, the City Commission approved a three-year General Utilities Services contract with Douglas N. Higgins, and in Resolution 18-322 the contract was extended for two years; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That a Task Order for Seawall Railing Replacement at City Marina, under the City's General Utilities Contract with Douglas N. Higgins, Inc., is hereby approved in an amount not to exceed \$196,660.00.

Section 2: That funds for this project will be paid from Garrison Bight account 413-7551-575-6300 (Project GB 1502). \$175,000.00 was allocated for FY 19/20, and additional funds totaling up to \$21,660.00 will be transferred equally from account 413-000-223-1400 (liveaboard surcharge B258) and 413-0000-223-1300 (charterboat surcharge), and any necessary budget transfers and adjustments are authorized.

Section 3: That the City Manager is authorized to execute necessary documents upon consent of the City Attorney.

Section $\underline{4}$: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
