## Disaster Loan programs

- Hurricane Dorian Disaster Loans
  - SBA can provide up to \$2 million to help meet financial obligations and operating expenses that could have been met should the disaster not have occurred.
  - Fixed rate loan; maximum rate is 4 percent.
  - The SBA customizes loan amounts and terms up to a maximum of 30 years for each applicant.
  - The filing deadline for is August 13, 2020.
- Emergency Bridge Loan Modifications
  - For Hurricane Irma and Hurricane Michael, EBL borrowers with a current balance in good standing may be eligible to term out existing EBLs for up to three (3) years (36 months) at fixed interest rate of six percent (6%) per annum.
