- **FEMA Grants**
 - **Irma CDBG-MIT Grant:** Awaiting Final RFP
 - **IRMA HMGP:** All projects: \$13.5M. Mgmt mtg 3/9 to find more money for Tidal Valves and Force Main projects.
 - **Irma CDBG-DR Grants: (\$1.78M) Force Main** (Match for Irma HMGP)
 - **Michael HMGP Tier 3:** Up to \$20M could be applied for. Mgmt mtg 3/9 to discuss priorities for applications.
- **2020 Water Supply Plan Update:** Adopting Miami Dade County's Water Fixtures Guidelines as an addendum to our Building Code. Got approval of 80% plan from Roy Bishop 2/24. 100% due 3/13 to new Planning Director, then on to Planning Board.
- **Army Corps Coastal Storm Study.** Attended ACOE presentation to BOCC ([Video on Demand](#)) on 2/19. Report recommends shoring up US1, fortifying critical structures and elevating residences. Would ask congress for allocation in 21/22. Mayor asked for briefing at future Commission Mtg. ACOE has reached out to CM to set up Presentation to management.
- **Adaptation Planning Team:** Next meeting 3/20
 - **Last Meeting Recap:** 2/21: Reviewed Army Corps report and draft 10 year CIP – Still have no true costs for bonding request and recommend using HMGP list. Staff is in support of contracting for a Resilience Master Plan.
 - **Resilience Master Plan:** CM call with Susy Torriente 2/24: Exploring expansion of Jacobs contract. Scope of work is being drafted.
 - **NEA Grant:** Meeting 2/25 got staff and partners all on the same page. NEA Cultural Plan will be presented to City Commission March 24th alongside Parks and Rec
 - **Elevating Houses:** Seagrant Application (\$28.5K) for Education & Organization passed Grant Review 2/21, turned in 2/28.
- **UF FIBER Partnership:** Collaborated with UF and American Wetlands Association on their grant pre-proposal to bring FIBER to Key West. Will know in late March if a full proposal is requested.
