On November 22 at 0142 hours Ofc. Tellier was conducting an area check at 400 Whitehead Street (US Post Office). Ofc. Hudson and I, Ofc. Lopez, were at the same location with Ofc. Tellier. Using his spotlight, Ofc. Hudson saw a white male laying on the ground next to a red 2011 Mazda on the driver side. Ofc. Hudson drove his car over to the male and I walked.

Ofc. Hudson observed a male sleeping in the parking lot. The male was in a seated position against the driver side door of a parked vehicle. Ofc. Hudson and I approached the male to perform a welfare check. Ofc. Hudson began talking to the male and he attempted to stand up. The male was drooling and had saliva running down his shirt. The male was highly intoxicated, either on drugs or alcohol. Ofc. Hudson and I advised the male to remain seated and he continued to attempt to get up on his own. I asked the male for his name and he could not speak clearly due to his level of intoxication. I asked the male what city was he in at the moment and he attempted to say it, but he had a slurred speech. I asked the male if he had a wallet, in an attempt to locate a key card from a hotel and then provide him with a courtesy ride. The male began shaking his head side to side after I asked him if he had a wallet on him. Ofc. Hudson asked the male to give him the key of his hotel. Again, we were trying to ascertain what hotel he was staying in. The male began grabbing the door handle of the Mazda. Ofc. Hudson and I kept telling the male to stop grabbing the door handle and he continued grabbing the door handle. I observed a bulge on the male's right pocket, and I told the male I was going to assist him to get his wallet.

I located a California driver's license in the male's wallet. The male was identified with his California driver's license as, Aaron Van Seidle (dob:12/11/1998). I asked to Key West communications to perform a license check. They informed me the license number returned to a female with the name of Michalina Anne, (dob:10/23/1956). Ofc. Tellier asked Communications to perform a name check on Aaron Van Seidle, (dob:12/11/1998). Communications informed us they did not get a return under that name. I later located a key card from the Gates Hotel in Seidle's wallet, and I asked him if knew his room number and he said, "No".

Ofc. Tellier informed the male was in possession of a false identification and that he was in possession of an alcoholic beverage by a person under 21 years of age.

Aaron was later identified with a valid Indiana driver's license as Aaron Charles Seidle, (dob:12/11/2001).

Ofc. Hudson and I instructed Seidle to place his hands behind his back. While I was attempting to cuff Seidle, he tensed both of his arms. I instructed Seidle to un-tense them so I could place the second handcuff on his hand and then Seidle complied.

Ofc. Hudson and I then began to walk Seidle to my police car for transport. After a few steps, Seidle stopped walking and began pushing backward. As I began to place Seidle in a shoulder lock transporter hold to assist him in walking, he began to move quickly forward as if he was trying to run away. Seidle was redirected in a controlled manner to the hood of Ofc. Hudson's patrol vehicle. Seidle then violently hit his face on the hood. This caused him to bleed all over the hood. Seidle, using his torso, immediately tried to push back and turn toward us. Officer Hudson, R. Perez, and I were able to gain control of Seidle while Officer Tellier brought my police car closer.

I told Seidle we were going to stand him up and walk him to another vehicle. Seidle told us he would not resist. He was walked to the rear passenger side of my police car. Seidle said he would not get into the vehicle. Ofc. Hudson and I asked Seidle multiple times to sit in the vehicle. Seidle refused. I attempted to assist Seidle into the vehicle by

pushing his head forward (essentially trying to lean him forward). Seidle again began to push back. Ofc. Hudson took out his TASER, removed the cartridge, armed it, and placed in the middle of Seidle's back. The TASER was deployed for a cycle (5 seconds). Seidle pushed back, turned his body and began pulling away from me. Seidle and I then fell to the ground. Ofc. Tellier and Ofc. Hudson grabbed Seidle's legs to gain control.

Seidle reached for Ofc. Tellier's hands and grabbing both of them. He squeezed and dug his fingernails into Ofc. Tellier's hands. Ofc. Tellier gave several loud repetitive commands to Seidle to let go. Seidle did not comply and refused to let go. Ofc. Hudson discharged a short burst of agency issued OC spray to Seidle's facial area. Seidle then released Officer Tellier's hands. Ofc. R. Perez placed a spit hood on Seidle as he was spitting toward officers.

Ofc. Hudson removed one hand from Seidle's legs to use his radio, and Seidle freed both of his feet and in a violent kicking motion, kicked him in the testicles. Ofc. Hudson asked Sergeant Sims and Rescue to respond to the scene. Rescue evaluated Seidle and determined he did not need to be transported to the ER, as his injuries were minor.

I placed Seidle in the rear side of my police car with the assistance of Ofc. R. Perez. I transported Seidle to the Monroe County Detention Center.

The nurse at the MCDC advised me Seidle needed to be cleared from the Lower Keys Medical Center first. I transported Seidle to the Lower Keys Medical Center for clearance. He was cleared and then later transported back to the MCDC.

Ofc. Hudson and Ofc. Tellier and Ofc. R Perez later completed their supplemental reports.

This incident was recorded with my body worn camera, 3722.

Based on the fact and evidence, Aaron Seidle did knowingly have in his possession a fictitious California driver's license as, Aaron Van Seidle, (dob:12/11/1998). Seidle was later identified with a valid Indiana driver's license as, Aaron Charles Seidle, (dob:12/11/2001). Contrary to F.S.S. 322.212.

Based on the fact and evidence, Aaron Seidle did knowingly have in his possession a second fictitious California driver's license as, Aaron Van Seidle, (dob:12/11/1998). Seidle was later identified with a valid Indiana driver's license as, Aaron Charles Seidle, (dob:12/11/2001). Contrary to F.S.S. 322.212.

Based on the facts and evidence, Aaron Seidle did actually intentionally willfully and maliciously kick Ofc. Hudson. He kicked him in the testicles. Seidle did not stop kicking Ofc. Hudson after he was given several loud repetitive verbal commands to do so. Ofc. Hudson is a certified Law enforcement Officer in the State of Florida. Ofc. Hudson was wearing his KWPD class B uniform. Ofc. Hudson was easily recognizable as a Law Enforcement Officer and all officers on scene were driving KWPD marked patrol cars. Contrary to F.S.S. 784.07(D).

Based on the facts and evidence, Aaron Seidle did actually intentionally willingly and maliciously reach up and grab both of Ofc. Tellier's hands, as squeezed and dug his fingernails into Ofc. Tellier's hands. Seidle did not let go Ofc. Tellier's hands after he was given several loud repetitive verbal commands to do so. Ofc. Tellier is a certified Law enforcement Officer in the State of Florida. Ofc. Tellier was wearing his KWPD class B uniform. Ofc. Tellier was easily recognizable as a Law Enforcement Officer and all officers on scene were driving KWPD marked patrol cars.

Based on the facts and evidence, Aaron Seidle did resist, obstruct and oppose to follow my verbal commands. I instructed Seidle to stop tensing his arm when I attempted to place handcuffs on him, and he continued tensing up. Then he tried to pull away and threw himself onto the hood of a patrol car. After, I instructed Seilde to get in the police car and he refused to get in my police car numerous times. He tensed his body and tried to run away again. I was easily recognizable as a Law Enforcement Officer and all officers on scene were driving KWPD marked patrol cars. Contrary to F.S.S 843.02.

Based on the facts and evidence, Aaron Seidle did knowingly and willfully and intentionally resist and oppose to follow verbal commands from Ofc. Hudson, Ofc. Tellier and I. Seidle kicked Ofc. Hudson in the testicles and grabbed Ofc. Tellier's hands in an aggressive manner. Seidle was acting in a very aggressive manner and became very violent. Ofc. Hudson, Ofc. Tellier and I were easily recognizable as Law Enforcement Officers and engaging in our legal duties as Officers. We were dressed in our KWPD Class B uniforms and were driving KWPD marked patrol cars. Contrary to F.S.S 843.01.

On 11/22/2020 at approximately 0142, while on routine patrol in the City of Key West, I observed a white male subject leaning against a red sedan, in the seated position, and asleep in the parking lot of 400 Whitehead St (United States Post Office). Officer Lopez and I woke the male, who had a strong odor of alcoholic beverage emanating from his person and asked him if he was okay. I asked the male if he was staying in a hotel, he said yes. I asked if he had a room key in effort to assist him back to the correct hotel. He said yes. Officer Lopez assisted him in finding his room key.

Officer Lopez identified the male subject by a California driver license located inside of his wallet that provided the name and DOB as, Aaron V. Seidle 12/11/1998. When Officer Lopez conducted a person's check on Seidle, the return on the driver's license number came back to an older female with a different name.

Officer Tellier located various school identification cards for Seidle inside of his wallet that identified him as a senior in high school for the 2019-2020 school year.

Seidle then stated he was 18 years old.

Officer Lopez and I instructed Seidle to place his hands behind his back. While Officer Lopez was attempting to cuff Seidle, he tensed both of his arms. Officer Lopez instructed Seidle to un-tense so he could place the second handcuff on his. Seidle complied.

Officer Lopez and I then began to walk Seidle to Officer Lopez's police car for transport. After a few steps, Seidle stopped walking and began pushing backward. As I began to place Seidle in a transport hold (shoulder lock) to assist him in walking, Seidle began to move quickly forward as if he was trying to free himself. Seidle was turned toward the front passenger side fender of my patrol vehicle in effort to stop him. Seidle lunged forward and hit his face against the hood. Seidle immediately tried to push back and turn. Officer Lopez, R. Perez, and I were able to gain control of Seidle while Officer Tellier brought Officer Lopez's patrol car closer.

I told Seidle we were going to stand him up and walk him to another vehicle. Seidle told me he would not resist. He was then walked to Officer Lopez's rear passenger vehicle door. Seidle said he would not get into the vehicle. Officer Lopez asked Seidle multiple times to sit in the vehicle. Seidle refused. Officer Lopez attempted to assist Seidle into the vehicle. Seidle again began to push back. I drew my agency issued Taser, removed the cartridge, armed it, and placed in the middle of Seidle's back. I did not complete one five second cycle. Seidle pushed back, turned his body and began pulling away. Seidle and Officer Lopez then fell to the ground.

Officer Tellier and I grabbed Seidle's legs to gain control.

I removed one hand from Seidle's legs to key my radio and Seidle freed both of his feet and kicked me in the testicle's multiple times. I applied approximately four hammer fist strikes to Seidle's thigh area in an effort to get Seidle's legs under control. He again became compliant.

Sergeant Sims and Rescue responded.

Seidle was then placed in the rear passenger seat of Officer Lopez's and transported to Lower Keys Medical Center for medical clearance.

Officer Lopez later identified Seidle by an Indiana driver's license with the same name and the date of birth of 12/11/2001.

All of the above was captured on my bodyworn camera, 3940.

Nothing further at this time.

On 11/22/2020, at approximately 0143 hours, I (Ofc. R. Perez) responded to 400 Whitehead St. to assist with an intoxicated subject.

Upon arrival I noticed Ofc. Lopez, Ofc. Hudson and Ofc. Tellier speaking to a male later identified as Aaron Seidle. I stayed in my patrol vehicle to not interfere with their investigation, but I was watching the Officers to make sure everything was good. Seidle was placed in handcuffs and was being walked toward Ofc. Lopez's vehicle. Seidle started to twist and tried to pull away from Ofc. Lopez and Ofc. Hudson. I exited my vehicle and assisted the two Officers in detaining Seidle on the hood of the patrol vehicle. Ofc. Hudson and Ofc. Lopez took Seidle off the hood of the vehicle and attempted to walk him toward Ofc. Lopez's vehicle again. Ofc. Tellier took Lopez's keys and drove Lopez's vehicle closer to us. When Seidle was being walked toward Lopez's vehicle, I ran to the driver side, unlocked the doors, opened the back-door opposite of where Seidle was being placed to assist in putting seidel in the vehicle and buckling his seat belt.

Seidle pulled away from Hudson and Lopez and began to run away. I heard the sound of a TASER being deployed. Lopez held on to Seidle's arm and Seidle fell to the ground. Hudson, Lopez, Tellier and I, held Seidle down on the ground. While on the ground, Seidle started kicking and flailing around on the ground striking Hudson several times with his legs. Tellier retrieved a hobble and tied Seidle's legs up to stop him from kicking us. Seidle grabbed Tellier's right hand and would not let go of it. Tellier's hand was caught in the cuffs causing damage to them. Seidle was instructed several times to release Tellier's hand and he refused. Hudson walked over and sprayed Seidle in the face with OC spray in an attempt to get Seidle to release Tellier's hand. Seidle released Tellier's hand and began to scream and spit. Tellier told me to let go of Seidle and retrieve a "spit mask" from my vehicle to prevent Seidle from spitting on us. I ran to my car, opened my truck, retrieved a "spit mask" and returned to Seidle. I placed the mask on Seidle's head to stop him from spitting on us. We contacted dispatch and advised to send an ambulance and Sgt. Sims.

Rescue 2 arrived on scene evaluated Seidle and determined that he was fine and would be ok to be transported to the Monroe County Detention center.

Sgt. Sims arrived on scene and attempted to speak with Seidle. Seidle screamed and refused to listen to Sgt. Sims. We placed Seidle in the back seat of Lopez's vehicle and transported him to MCDC. I followed Lopez to the jail to assist with Seidle.

On 11/22/2020 at 0142 hours I, (Ofc. J. Tellier) was conducting an area check at 400 Whitehead Street (US Post Office). Ofc. Hudson and Ofc. Lopez were with me. Using his spot light, Ofc. Hudson saw a white male laying on the ground next to a red 2011 Mazda on the driver side. Ofc. Hudson drove his car over to the man and Ofc. Lopez walked.

The man was woken up. He was unsteady on his feet. He swayed when he stood. I ran the tag for the Mazda (FL KUNQ18). The vehicle was registered to a woman Theresa Connel from Key West. The vehicle was not registered to the man and he kept trying to open the driver side door, yanking on the handle to the point where Ofc. Lopez had to tell him repeatedly to stop. Ofc. Lopez found a wallet in the man's pocket. Inside the wallet was a California license of C3357910 which comes back to, Michalina Anne, who is 5/4" tall and 64 years old. The man's photo was on the license, but he was clearly not a 5'4" tall or a 64 year old woman.

I walked back to the man and asked him what his date of birth was, and he stated the answers were in the cards. Inside his wallet I found several high school student ID cards with his picture on them. His name according to his ID cards was, Aaron Charles Seidle, but the cards had no date of birth.

I advised Ofc. Lopez that Seidle was in possession of a fake driver's license, was in possession of an alcoholic beverage by a person under 21 years of age, and obstructing justice by refusing to provide us with a date of birth.

Ofc. Lopez and Ofc. Hudson handcuffed Seidle and began to escort Seidle to Ofc. Lopez's patrol car. While walking Seidle pulled away and lunged at the hood of Ofc. Hudson's patrol car. Seidle fell on the hood and was secured. I ran over to ofc. Lopez's patrol car and pulled it forward so we could place him inside without further incident. Ofc. Hudson requested a supervisor in reference to Seidle pulling away and landing on the hood of a patrol car.

Once escorted over to Ofc. Lopez's patrol car, Seidle refused to get in. He would not sit and he proceeded to attempt to negotiate with us. Ofc. Lopez tried numerous time to place him in the patrol car. Seidle tensed his body every time Ofc. Lopez tried to get him to sit down.

Ofc. Hudson told Seidle if kept resisting (tensing his body and trying to turn away from the car) that he would be TASED. Ofc. Hudson attempted to drive stun Seidle in his back. Seidle turned away from the car and tried to run away while handcuffed, and he was dragging Ofc. Lopez with him. Seidle fell to the ground with Ofc. Lopez on him. Once on the ground, Seidle tried to sit up. We (Ofc. Lopez, Ofc. Hudson, and I) tried to keep Seidle on his side. He was kicking, so I ran over to my patrol car and grabbed a hobble. I hobbled Seidle's legs, which enraged him. He was facing away from me and with his handcuffed hands he reached out and grabbed both of my hands. He squeezed and dug his fingernails into my hands. I gave Seidle loud verbal commands to let go of me. I was able to get my right hand

free, still yelling for him to let go. I was unable to free my left hand, and I could not reach my TASER. My only other weapon was my right fist. I began punching Seidle's hand, while he was squeezing my left hand harder. I delivered several knee strikes to Seidle's right butt cheek, but he would not let go. Ofc. Hudson was sitting on Seidle's legs, and reached around Ofc. Lopez and used OC spray on Seidle. He finally let go of my hands and began screaming as loud as he could. While screaming Seidle kicked Ofc. Hudson in the testicles (with his feet still hobbled).

Sgt. Sims and KWFR arrived on scene. Ofc. Perez placed a spit hood on Seidle because he had been sprayed with OC spray and was spitting. Sgt. Sims spoke with Seidle and took pictures for his report. Seidle was evaluated by rescue. Ofc. Lopez and Ofc. Perez (who was also on scene at this time) escorted Seidle to Ofc. Lopez's patrol car. I repositioned Seidle's hobble so he could walk to the car. Ofc. Lopez transported Seidle away from the scene.

This concluded my time with this case.
