A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, **APPROVING** ATTACHED "INTERLOCAL **AGREEMENT** FOR CONSTRUCTION SERVICES FOR WHITEHEAD AND FRONT STREET IMPROVEMENTS" (ILA) BETWEEN THE FLORIDA KEYS AQUEDUCT AUTHORITY AND THE CITY OF KEY WEST; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS AND TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Whitehead and Front Streets are scheduled for pavement rehabilitation, and FKAA has concurrent requirements to upgrade infrastructure on Front and Whitehead Streets. City staff intends to coordinate repairs with FKAA and Monroe County to minimize impacts to the public, and avoid cuts to new streets and sidewalks; and

WHEREAS, City staff recommends approval of the attached ILA, which allows the City, FKAA and Monroe County (which is jointly responsible for portions of Whitehead Street) to cost-share design and construction expenses and coordinate tasks, to benefit the residents and visitors of Key West; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached "Interlocal Agreement for Construction Services for Whitehead and Front Street Improvements" between Florida Keys Aqueduct Authority and the City of Key West is hereby approved.

Section 2: That design of this project will be funded from account No. 102-4102-541.6300 (Internal Improvements/ Streets), Project #II41021902. Upon record of payment, the City will submit reimbursement requests to FKAA for FKAA's share of the scope of work. Any necessary budget transfers and adjustments are hereby approved.

Section 3: That the City Manager is authorized to execute the interlocal agreement, and any necessary documents for this project, upon consent of the City Attorney.
