A RESOLUTION OF THE CITY COMMISSION OF THE WEST, CITY OF KEY FLORIDA, RESCINDING RESOLUTION 21-088, WHICH APPROVED A "PUBLIC **AMENDMENT** TRANSPORTATION THE TO TRANSPORTATION AGREEMENT" (PTGA) FM 444447-1-BETWEEN THE FLORIDA DEPARTMENT TRANSPORTATION (FDOT) AND THE CITY OF KEY WEST FOR THE MALLORY T-PIER EXTENSION/IMPROVEMENTS PROJECT TO ADD FISCAL YEAR 2021 FUNDING; AUTHORIZING THE INTERIM CITY MANAGER EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on May 4, 2020, in Resolution No. 21-088 the City Commission on its consent agenda approved a PTGA for Fiscal Year 2021 Funding for certain work at Mallory T-Pier Extension/Improvements; and

WHEREAS, the City Commission has determined that the item is ripe for reconsideration, and it is in the best interests of the City and its voters to rescind the resolution, in order to discuss the scope of work that the PTGA is designated to fund in part; and NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That Resolution No. 21-088 is hereby rescinded, and the "Public Transportation Amendment to the Public Transportation Agreement" (Financial Project Number 444447-1-94-01, Contract G1767) for Mallory T-Pier (Seaport Investment Page 1 of 3

Program) is not accepted and approved.

Section 2: That budget amendments are hereby authorized to reflect the refusal/return of grant funds and matching funds that were previously budgeted for the project (Project Number IS43022003).

Section 3: That the City Manager is authorized to execute any necessary documents to ensure this Amendment to PTGA is cancelled, unless otherwise reconsidered by the City Commission.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
