
UPP Global is currently active in 9 states along the Eastern Seaboard, with over 250 individual locations, and 400+ employees.

Proposal

- □ **FLParkingCO.** will manage, staff, and perform all active operations, as they relate to the City of Key West municipal parking program.
- FLParkingCO. will provide all necessary project infrastructure, including but not limited to: LPR equipment and systems, any new Flowbird pay stations that may be needed, maintenance and repairs on existing pay stations, ADA compliant portable pay station installation bases, and any necessary signage.
- □ FLParkingCO. has unlimited access to equipment and will pay for and provide all necessary project infrastructure, at zero up front cost to the County, and will amortize the costs at zero percent interest over the term of the contract. Additionally, regarding the equipment and infrastructure, we will be prepared to prove that we are provided with the lowest and most competitive pricing in the industry.
- □ FLParkingCO. is prepared to commit to the City of Key West, significantly increased parking project NOI, and will guarantee these increases and be bonded to do so. This increased NOI is not based on assumptions pertaining to rate structure increases, rather it is based on our confidence in our technologies and operational efficiencies.





Proposal

FLParkingCo. has an aggressive cost schedule and unique guaranteed revenue share commitment with our municipal clients. FLParkingCo will make a commitment to the City of Key West as follows:

- □ \$200k check written and issued to City of Key West to reimburse Capital Equipment costs incurred in 2020, amortized at zero-percent interest over the term of the agreement.
- □ Guaranteed base minimum of \$10M per year to City of Key West
- □ All Net Operating Income (NOI) over and above the base minimum of \$10M, will be split 50/50 between City of Key West and FLParkingCo.
