On 07/06/2021, around 23:24 hours, I (Ofc. Bozzetti) was dispatched to 3841 N Roosevelt Blvd, in reference to a suspicious incident involving a father and his 15-year-old daughter.

On arrival, the father, later identified as Nicholas Marshall, was standing outside of the front lobby speaking with hotel staff. I asked Nicholas to sit down on a nearby bench and explain what the issue was. Nicholas appeared extremely intoxicated, he was slurring his speech and had a strong odor of an alcoholic beverage emanating from his breath. Nicholas stated that his daughter, later identified as Isabelle Marshall, has been in town for the past 5 days staying with him because she had some issues with her mother up in Illinois. Nicholas stated that he provided Isabelle with a phone so she could speak with her mother through apps that use Wi-Fi such as "snapchat". Nicholas said Isabelle has a boyfriend in Illinois that he and her mother do not approve of. He said that whenever she tries to talk to him, he takes the phone away from her.

Nicholas stated that today after he got off work at 4pm, he took Isabelle to lunch at Jack Flats. After lunch he stated they began arguing and he put her in a cab by herself so she could go back to the hotel room. After putting Isabelle in the cab, Nicholas went to the Waterfront Brewery to continue drinking. After he was done drinking, he returned to the hotel room. Once he got to his room, he turned on the shower and went inside the bathroom. While in the bathroom he said he heard Isabelle on the phone with her boyfriend. He put a towel on and instructed his daughter to give him the phone. He said she wouldn't, so he physically took it out of her hands and then smashed the phone on the ground. Nicholas stated he never physically harmed his daughter.

After speaking with Nicholas, I went inside the hotel and spoke to Isabelle. Isabelle stated that she has not seen her father in two years and that her mother has full legal custody. Isabelle said she has been down here roughly a week. I asked Isabelle what happened today. She stated once her father got off work, they went to Jack Flats to eat lunch. She said he began drinking heavily there. After lunch he wanted to continue drinking so he put Isabelle in a cab by herself and set her back to the hotel room. He then went to the Waterfront Brewery to continue drinking. Isabelle said when he returned home, he appeared extremely intoxicated. She said he took his clothes off in front of her and went to take a shower. Before getting in the shower he came back out with a towel wrapped around his waist, pinned her on her back by laying on top of her and pressing both of her shoulders down, then ripped the phone from her hands. She said once he had the phone, he began slamming it on the ground until it appeared broken. Isabelle said after breaking the phone he walked back towards the bathroom. Isabelle said she was terrified, so she sprinted to the front door of the hotel room and ran downstairs to the lobby. Once she reached the lobby, she had a front desk employee call 911 for her. I did not see any visible marks

Isabelle's mother, later identified as Rebecca Hanna, lives in Rockwood Illinois, and has full legal custody of Isabelle. I contacted her via telephone and informed her of the incident. She stated she would begin working on arrangements to retrieve her daughter.

I contacted DCF and informed them of the incident. I spoke with Samantha, ID#: 158, and she advised me that she was passing the information on to a case worker and that a DCF employee would be on the way to take custody of Isabelle.

I advised Nicholas to turn around and place his hands behind is back. He put his hands behind his back and began to flex his arms and tense up. I told him to relax his arms and he complied. After Nicholas was in handcuffs, Ofc. Ham took control of him while I went to my patrol vehicle to unlock and open the back door. While doing this I saw Nicholas attempting to get away from Ofc. Ham in my peripheral's. Ofc. Ham still had a grip on Nicholas's left

arm. I approached Nicholas while he was still resisting Ofc. Ham and attempting to break free from Ofc. Ham's grip. Ofc. Ham gave a clear, loud, verbal command to stop resisting, however, Nicholas continued to struggle and not comply. I grabbed Nicholas's right arm and performed a modified leg sweep to take Nicholas to the ground in a controlled manner. I turned Nicholas on to his stomach and placed my knee across his back until he stopped resisting. Once Nicholas calmed down, I removed my knee from his back. Ofc. Ham and I placed him in the back seat of my patrol car without further incident. Nicholas sustained to very minor abrasions on his right elbow.

Sgt, Hammers arrived on scene to document an RRI incident.

I transported Nicholas to the MCDC without incident. Ofc. Ham transported Isabelle back to the Key West Police Department Station to wait for DCF to arrive. Ofc. Ham took photographs of the areas Isabelle stated her father used force to pin her down and uploaded the photographs to evidence.com.

Since Nicholas actually and intentionally touched or struck Isabelle against her will, and is her biological father, he was in violation of F.S.S. 784.03-1A1. (Domestic)

Since Nicholas resisted, obstructed, or opposed an officer in the lawful execution of any legal duty, he was in violation of F.S.S. 843.02

My BWC and In-Car COBAN were activated during this incident.

On July 6, 2021 at approximately 2324 hours, Ofc. C. Bozzetti and I (Ofc. S. Ham) were dispatched to 3841 N Roosevelt Blvd (Marriott Beachside), reference a suspicious incident.

Upon arrival, Ofc. Bozzetti was speaking to the father (Nicholas Marshall) and stated his daughter (Isabelle Marshall) was inside.

I spoke to Isabelle inside the lobby at Marriott Beachside. Isabelle stated she came to Key West to stay with Nicholas. Isabelle stated Nicholas took her out to dinner on Duval St. and Nicholas was taking shots of liquor at dinner. Isabelle stated Nicholas became intoxicated and she was ready to go back to their hotel. Isabelle stated she and Nicholas got inside of an Uber and were heading to the hotel when Nicholas decided he wanted to go to the Waterfront Brewery to drink some more. Isabelle stated Nicholas put her in another Uber and sent her back to their hotel room. Isabelle stated she spoke to her mom Rebecca on the phone before going back to the room and told Rebecca that Nicholas was drunk. Isabelle stated she had to use Nicholas' phone to call because he had disconnected her phone service. Isabelle stated when she arrived back at the hotel room, she began speaking to her cousin on snapchat. Isabelle stated Nicholas arrived shortly after and came in angry that she was using her phone. Isabelle stated Nicholas got naked in the bedroom and went inside the bathroom to shower. Isabelle stated while Nicholas was inside the shower, he began talking to himself. Isabelle stated when Nicholas got out of the shower he was upset because she was still on her phone. Isabelle stated she was laying on her back on the bed and Nicholas pressed her shoulders down on the bed to hold her down so he could take the phone. Isabelle stated Nicholas then grabbed ahold of her arms and then hands to snatch the phone away from her. Isabelle stated Nicholas took the phone and threw it against the ground to break it. Isabelle stated she waited for Nicholas to go back into the bathroom and then she ran out of the room to the lobby.

I asked Isabelle if she had any visible markings from the altercation and she checked inside of the women's restroom. Isabelle came back outside the restroom and pointed to her right collarbone stating it had some redness. I could see minor redness to the area at that time and asked if she could lift her sleeves so I could inspect any other possible marks on her arms or hands. I was unable to locate any other visible injuries on Isabelle's person.

Ofc. Bozzetti stated to me to monitor Nicholas as he went inside to speak with Isabelle.

Ofc. Bozzetti advised me that we were going to be taking Nicholas into custody. Nicholas placed both hands out in front of his body and said to arrest him. Ofc. Bozzetti told Nicholas to place his hands behind his back. Nicholas brought his hands around to his backside and began tensing up both arms. Ofc. Bozzetti told Nicholas to relax his arms and stop tensing. Nicholas complied and released his tension. Ofc. Bozzetti handcuffed Nicholas and turned away to open the backseat of his patrol vehicle. I had Nicholas by his right arm, and he tried to pull away from my grip. Nicholas raised both arms behind his body and positioned his feet as he was about to run. I told Nicholas to stop

resisting and I grabbed ahold of both of Nicholas` arms. Ofc. Bozzetti came around my left side and we escorted Nicholas to the ground in a controlled manner. Nicholas tried flailing his legs around once he was on the ground, so I maintained control of his legs while Ofc. Bozzetti controlled his upper body. Ofc. Bozzetti and I sat Nicholas up and escorted him to the backseat of his patrol car.

I escorted Isabelle to their room to retrieve her belongings. I transported Isabelle to the Key West Police Department to wait for a DCF personnel to respond. Upon arrival to the station, I photographed Isabelle's hands, arms, and collarbone area where she stated she was grabbed by Nicholas.

DCF agent arrived at the station and took custody over Isabelle. I went back to the Marriott Beachside with the DCF agent and Isabelle to retrieve Isabelle's ID card from the room. Isabelle entered the room and collected her ID card.
