Approve the following proposed changes to Article VIII - Charter Amendments; Records; Bonds:

### 8.01 Methods of amending Charter.

(b) (2) Each paper of a petition shall have attached to it when filed an affidavit executed by the circulator thereof stating they that he personally circulated the paper, the number of signatures thereon(,) that all the signatures were affixed in their his presence, that they believe he believes them to be the genuine signatures of the persons whose names they purport to be and that each signer had an opportunity before signing, to read the full text of the proposed charter amendment.

A motion was made by Mr. Cintron, seconded by Mr. Weekley, that Article VIII, Section 8.01(b)(2) shall read:

Each paper of a petition shall have attached to it when filed an affidavit executed by the circulator thereof stating they personally circulated the paper, the number of signatures thereon, that all signatures were affixed in their presence, that they believe them to be the genuine signatures of the persons whose names they purport to be and that each signer had an opportunity before signing, to read the full text of the proposed charter amendment.
