This is a case that was previously heard and fines were imposed for \$250.00 administrative cost and \$250.00 per count per day starting 21 October 2022. The fines ran until 28 December 2022 resulting in a \$17,000.00 plus \$250.00 administrative cost that the Respondent was trying to mitigate. The Respondent was offering to pay \$250.00 total for the fines. The Special Magistrate asked the Respondent why he should mitigate the fine. Hector Vazquez stated that he was confused about who he was talking to whether it was the City of Key West or Monroe County. Officer Doctoche then stated that she doesn't know why he would be confused since the emblems for the City and County are different, and that every notice she sent him it had her contact information so he could contact her and he never did. The Special Magistrate told the Respondent that because of the mitigation ordinance he could only mitigate the fine so much, and in this particular case he could mitigate the fine up to 50%. The Special Magistrate imposed a \$11,000.00 fine instead of the previous fine of \$17,250.00.
