An Ordinance of the City of Key West, Florida, adopting an Ad Valorem Tax General Municipal Millage Rate for FY 2021-2022; Providing for severability; Providing for repeal of inconsistent provisions; Providing for an effective date.

A motion was made by Commissioner Weekley, seconded by Commissioner Lopez, that the final adopted ad valorem tax municipal millage rate for FY 2021-2022 is hereby set at 2.1360 mills (2.1360 per thousand dollars of assessed property value). The 2021-2022 final adopted millage rate is equal to 5.50 percent more than the rolled back rate of 2.0246 mills (\$2.2046 per thousand dollars of assessed property value).
