This was a Mitigation case where the Respondent Michael Coppola was imposed a fine of \$16,250.00 and offered to pay \$5,000.00. Director Jim Young was present on behalf of the City. Attorney Robert Cintron was present

representing the Respondent. The Respondent took 99 days to come into compliance so the City Ordinance states that the fine can be mitigated no more than 50%. Attorney Cintron gave a testimony that Mr.Coppola was apart of a mortgage scam which led to this code case. The Special Magistrate asked Attorney Cintron how did the Respondent get into short term rentals. Attorney Cintron answered stating that Mr. Coppola inherited some of the property rentals. Director Jim Young stated that Mr. Coppola was not in the short term rental business he actually had a long term renter where he failed to renew his Business Tax Receipt. Director Young also said when Mr. Coppola came to renew his Business Tax Receipt the Cheif Licensing Official denied his application due to unpaid utility bill. The Special Magistrate stated that the \$5,000.00 the Respondent is offering to pay does not meet the requirements of the City Ordinance. Director Young stated that Attorney Cintron wanted to come to the hearing today because of the clause of Mitigation Ordinance about frustrating mitigations. The Special Magistrate asked Attorney Cintron why did it take Mr. Coppola 99 days to come into compliance. Attorney Cintron stated that he was so caught up in attending hearings for the mortgage scam and testifying against that person. The Special Magistrate decided on the 50% Mitigation where the Respondent is imposed \$7,875 and \$250.00 Administration fee.
